Carmona held at the Carmona Elementary School this November 10.

The activity solidifies the department's partnership with the LGUs as it pushes the KonsulTayo Campaign which aims to encourage Filipinos to get the care they need to avoid adverse health outcomes and increase public awareness against WILD diseases.

DOH CALABARZON Regional Director Ariel I. Valencia led the turn-over of the equipment and other supplies consisting of spray can insecticides, Larvicides, Insecticide Treated Screens, Dengue NS1 Rapid Diagnostic Tests, Antigen and Antibody Tests, Oral Rehydration Salt, and Paracetamol.

According to RD Valencia, Carmona was chosen as the pilot area since it is one of the localities affected by the recent typhoons.



DBM eyes P28.9-B support for local governments in 2023

The Department of Budget and Management (DBM) is proposing a PHP28.9 billion Local Government Support Fund (LGSF) to raise the capability of local government units in assuming devolved functions under the Mandanas-Garcia ruling.

Budget Secretary Amenah Pangandaman said in a press briefing at the regional DBM office here late Wednesday that the proposed 2023 LGSF is higher than the PHP17.96 billion actual allocation this year.

"To facilitate this transition towards full devolution, our proposed budget next year provides allocations to empower the local government in delivering the services that have been devolved to them, including the PHP28.9 billion LGSF," said Pangandaman, who was in the city to grace the Visayas area conference of local budget officers.

Of the proposed budget, PHP10 billion is intended for the Support to Barangay Development Program (SBDP) under the National Task Force to End Local Communist Armed Conflict (NTF-ELCAC), PHP13.87 billion for the growth equity fund (GEF), and PHP5 billion for financial assistance (FA) to local government units and support for capital outlay and programs.

The SBDP is a hallmark program of the NTF-ELCAC created to bring progress to former conflict-prone communities. Among its projects are the construction of farm-to-market roads, health stations, rural electrification, school buildings, and water and sanitation systems.

The LGSF-GEF, on the other hand, was formed to provide additional funding to local governments that are identified as poor, disadvantaged, and lagging to support the implementation of their priority projects and services to be allocated to provinces (10 percent), cities (10 percent), municipalities (70 percent), and barangays (10 percent).

The PHP5 billion for LGSF-FA will be used by local governments to fund the eligible programs and projects, such as infrastructure; purchase of ambulances and other vehicles; purchase of medical, rescue, and disaster-related equipment; street lighting or rural electrification; installation of closed-circuit television surveillance system; and assistance to



poor individuals or families. Samar Governor Sharee Ann Tan thanked the national government for setting aside a higher LGSF in 2023 that would help underdeveloped areas in the

"It augments what the local government cannot provide since we only have PHP400 million local development fund this year. The amount is divided by 24 towns, two cities, and 951 villages," Tan said.

Pangandaman said President Ferdinand R. Marcos Jr. directed the review of functions that should be devolved to local governments vis-a-vis those that should remain with the national government. The period for the devolution of some functions is extended up to 2027 instead of 2024.

Last year, then president Rodrigo Duterte issued a directive to boost the local government's preparation for more responsibilities with the implementation of the Mandanas-Gar-

cia ruling in 2022. The Supreme Court Mandanas-Garcia ruling resulted from the petition made by Batangas Governor Hermilando Mandanas and former Bataan governor Enrique Garcia Jr. before the Supreme Court on local government shares on internal revenue allotment (IRA).

With the increased budget share, the LGUs are expected to be responsible for the funding and delivery of the activities, which have been devolved to them under Republic Act 7160, the Local Government Code of 1991, and other subsequent laws

Among the functions assigned to local governments based on the Local Government Code are agriculture programs, local infrastructures, environmental services, revenue mobilization, health services, maintenance of peace and order, employment facilitation, transportation, tourism, and housing. (PNA)

PH youngest organ donor hailed for heroic deed

Three-year-old Ezra Jacob Rosario will continue to live and be remembered beyond his death, after his parents decided to donate his organs and tissues so that others may live.

The young boy figured in a drowning incident just a day after the church wedding of his parents, who were visiting the Philippines from the United States. Ezra was rushed to the St. Luke's Medical Center in Metro

Manila but despite numerous attempts to revive him, he was pronounced "brain dead."

Coming from a family of doctors, his family decided to donate his two kidneys which were transplanted to a 24-year-old recipient. His corneas, meanwhile, have been banked at the Eye Bank Foundation of the Philippines

In a statement, the Human Organ Preservation Ef-

fort (HOPE) of the National Kidney and Transplant Institute (NKTI) hailed Ezra as the country's youngest organ donor so far and thanked his family's generosity despite the loss of a loved one.

"We would like to extend our sincerest condolences to the family of our young hero and our heartfelt appreciation for their brave decision. Thank you for your generosity to help others despite the painful loss. May

God bless your kind hearts all throughout this lifetime," the NKTI said on Facebook.

In a public Facebook post, Ezra's mother, Jennae, said, "This is the legacy we can give to our child, so he lives on in the lives of others through sacrifice and the gift of generosity."

Jennae said his son, who has a twin brother named Elijah, will be remembered as "a fighter, a brave, strong, kind, generous boy who fought his hardest battle and ultimately won through his generosity and love."

In a separate interview, Ezra's grandfather, Dr. Medeldorf Gaoat, who is also a provincial board member of Ilocos Norte, said it was an "honor" to have a grandson who died as a young hero.

While no one was to blame for the accident, the provincial board member said he will be initiating safety measures to ensure that swimming pools, especially those that flow into rivers and beaches, are properly guarded to avoid similar incident in the future.

As of this posting, Ezra's remains lie at the Gaoat family house in Barangay Ben-agan, Batac City in Ilocos Norte province until Nov. 19.

His body will be cremated so that his family could bring his ashes back to the United States. (PNA)

Provinces under state of calamity are Cavite, Laguna, Batangas, Rizal, Quezon, Albay, Camarines Norte, Camarines Sur, Sorsogon, Catanduanes, Masbate, Aklan, Antique, Capiz, Guimaras, Iloilo, Negros Occidental, Basilan, Lanao del Sur, Tawi-Tawi, Sulu, Maguindanao del Norte and Maguindanao del Sur. In Cagayan, the towns that are under the state of calamity include Amulung, Enrile, and Tuguegarao. In Marinduque, these areas are Mogpog, Santa Cruz and Buenavista, and in Cotabato, these are Pigcawayan, Libungan, and Midsayap. Other areas also declared under state of calamity include Muntinlupa City, Calbayog in Samar, Sirawai in Zamboanga del Norte, and Zamboanga City in Zamboanga del Sur. Under the CLAP, qualified members in Paeng-affected areas can borrow a loan equivalent to their one monthly salary credit or up to P20,000. The calamity loan is payable in two (2) years or 24 equal monthly installments with an annual interest rate of 10%.

Likewise, the SSS will provide financial aid to SSS and EC pensioners in typhoon-hit areas. "Pensioners may avail of the Three-Month Advance Pension wherein SSS pensioners will be given three months advance of their total monthly pen-

Korean-funded mold technology support hub opens in Cavite

The Mold Technology Support Center (MTSC) funded by the Korean government for USD8 million officially opened in General Trias, Cavite on Thursday.

The MTSC, which is poised to be a premier training hub for mold technologies, will be managed by the Department of Science and Technology-Metals Industry Research and Development (DOST-MIRDC).

It houses equipment, tools, and various technologies for mold and mold-related requirements of the industry.

The establishment of the MTSC aims to help advance local mold companies, increase their productivity, and help them become globally competitive.

At the MTSC launch, MIRDC executive director Robert Dizon said the facility will also help strengthen the industrial cooperation between the Philippines and the Republic of Korea.

"Korean partners who supplied all the equipment are here to demonstrate and encourage more local companies to avail of MTSC's services.

Not only did they provide the equipment, but our Korean partners made sure to boost the skills and technical know-how of our MTSC engineers and staff," Dizon said.

Seven engineers and technicians from the MIRDC and the Philippine Die and Mold Association (PDMA) trained on technical drawing, mold design, programming and operations, and mold assembly in South Korea from September to December 2019.

According to the MIRDC, the MTSC will be instrumental in beefing up the local economy. In Cavite alone, the MTSC will be able

to provide its services to over 200 companies. Companies in the molding industry are those which manufacture household products such as bottles, gadget casings, food containers, and toilet seats, among others.

The facility is located on a Philippine Economic Zone Authority-owned land near the Cavite Economic Zone.

Aside from providing training on mold making, the MTSC will accept mold-making jobs. Those interested may reach out to the MIRDC or the PDMA, especially if they are members of this association.

Dizon earlier said trainees may learn the basics like technical drawing, wherein they would only need a computer and software.

The training may last for two months because of the various modules that participants would need to take up. (PNA)

Extension of Special Privileges under the Fortuitous Events until December 31, 2022

Pursuant to Proclamation No. 57, s. 2022, further extending the period of a State of Calamity throughout the country due to COVID-19, the Corporation hereby informs all members and beneficiaries, partner health care providers and other stakeholders of the continuing grant of special privileges due to a fortuitous event.

As provided for in PhilHealth Circular No. 2020-0007, the privileges include submission of claims up to 120 calendar days from the date of discharge, and exemption from the rule of 45-day benefit limit and single period of confinement. The privileges mentioned will remain in effect until December 31, 2022, unless earlier terminated or extended through an official issuance.
