

Solon welcomes P114-B funding for PH's railway modernization

A leader of the House of Representatives on Thursday lauded the almost five-fold increase in the proposed funding totaling PHP113.99 billion for next year to modernize the country's railways as it would help solve the Philippines' transportation problems.

In a statement, House Majority Leader Manuel Jose "Mannix" Dalipe said the "massive increase" to finance the expansion of the country's railways shows the Marcos administration's commitment in developing a "fast, efficient, and easily accessible mass transportation system" and in decongesting traffic in Metro Manila and other metropolitan areas.

Dalipe noted that the proposed budget for railway modernization swelled to PHP113.99 billion for 2023, which is almost five times the previous budget of PHP23.12 billion in 2022.



He said next year's proposed budget would finance various big-ticket railway projects, particularly in building an additional 1,200 kilometers of railways which could provide transportation for 4.5 million passengers a day.

"We are happy that the new administration's thrust in solving our transportation problem is to expand and modernize our railways. This should have been the priority a long time ago and we would

never have to endure the monstrous traffic in Metro Manila. The railway is still the easiest and fastest way to transport people, not cars," Dalipe said. "We will not just solve our traffic problem but we can also decongest Metro Manila's population. If we have a modern rail system. Filipinos would definitely choose to live outside of Metro Manila," he added.

He also lauded the appointment of Transportation Secretary Jaime Bautista and Undersecretary for Rails Cesar Chavez, both of whom are experts in the railway and transportation sector and have a very deep background in the various railway projects that are part of the government's long-term development agenda. Their appointments, he said, show President Ferdinand Marcos Jr.'s resolve in ful-

filling his promise to develop a world-class national railway system. "Our long-term goal should be to continuously increase the coverage of our light rail system in Metro Manila and its nearby provinces and extend our rail connection to Luzon, Visayas, and Mindanao," he said. In his first State of the Nation Address, Marcos said he is determined to continue his predecessor's ambitious "Build, Build, Build" infrastructure program but with a new focus on developing the country's railway system.

"We shall confidently build on this firm foundation established by my predecessor. As it is in building an edifice. We must keep the momentum. And aspire to 'Build Better More," Marcos said. Marcos said the government missed a great opportunity to develop our rail transport system. "It is clear in our mind that railways offer great potential as it continues to be the cheapest way of transporting goods and passengers," he added. Marcos pointed out that there are a dozen rail projects -- at ground, above the ground, and below ground, not just in the National Capital Region, but in five other regions -- at various stages of implementation, and with a combined cost of PHP1.9 trillion. He also said larger scale railway

systems like the 102-kilometer Mindanao Railway Project; Panay Railway Project; and Cebu railway system could be integrated as a vital part of the transport and communications systems. Marcos directed the Department of Transportation (DOTr) to build upon already existing lines by modernizing old railway systems.

"Full speed ahead! Improving our railway system, along with modernizing existing airports and seaports, will maximize our strategic location in the Pacific. And

connect our many islands," he said. He also maintained that his administration is committed to finish building the current portfolio of investments: approved railway projects such as the North-South Commuter Railway System; the 33-kilometer Metro Manila Subway Project; the 147-kilometer North-South Commuter Railway System; the 12-kilometer LRT-1 Cavite Extension; the 23-kilometer MRT-7 and the Common Station that will connect LRT-1, MRT-3 and MRT-7. ed. We are past the stage of to cancer control and cancer passing blame on who or what was responsible for the perceived reduction to zero of the two cancer spending earmarks in next year's proposed national budget.

In fairness to the DBM, the "mother funds" under which the Cancer Control Program and the Cancer Assistance Fund were lodged did not suffer any cuts in the proposed 2023 national budget.

Intact pa rin po. Yung parehong mother fund, may increase. Ang tinanggal lang ay ang "earmarks" specifying the amounts that will go assistance.

Under the 2022 GAA, ang Cancer Control Program (P787 million) ay nasa ilalim ng "Prevention and Control of Non-Communicable Diseases" na may budget na P1.38 billion.

At ang Cancer Assistance Fund naman (P529 million) ay bahagi ng "Social Health Protection Program" na may budget na P21.9 bil-

Sa ilalim ng panukalang 2023 national budget, ang panukalang budget para sa "Prevention and Control of Non-Communicable Diseases" ay itataas sa P2.1 billion at ang sa "Social Health Protection Program" naman ay aangat bahagya at magiging P22.4 billion.

Ibig sabihin walang kaltas, may dagdag pa nga; pero ang nabura ay ang earmarks which reserved specified amounts for cancer control and cancer assistance.

How do we cure this oversight?

What the House should do is not to merely restore the earmarks, but to increase the funding for both cancer control and cancer assistance, and make them distinct and separate programs.

What should be done is not to increase the slice of cancer programs in the budget pie, but to increase the pie itself. Cancer should not compete with other diseases in the two mother funds.

I propose a P1 billion fund for cancer control and cancer assistance and I believe that fiscal space can be created to accommodate it.

Cancer killed almost 60,000 Filipinos last year, or one every nine minutes. Seven in 10 cancer patients drop out of treatment regimen for lack of funds. Most families is one cancer diagnosis away from bankruptcy.

As they say, cancer is a disease, not a sentence. And in the budget, fighting it must be a line item.



Maagap na desisyon ng ERC, susi sa pagpapanatiling abot-kaya ng kuryente

Hiniling ng SMC Global Power Holdings Corp (SMCGP) at Meralco sa Energy Regulatory Commission (ERC) na pansamantalang payagan itong itaas ang presyo ng kuryenteng galing sa Sual Coal at Ilijan Natural Gas power plants.

Kamakailan lamang ay ginanap ang unang ERC hearing kung saan isinaad ng dalawang kumpanya ang dahilan para sa naturang petisyon.

Ang power supply agreement (PSA) sa pagitan ng Meralco at SMCGP ay isa sa pinakamalaking kontratang pang enerhiya sa bansa, kung saan ang presyo ay "fixed rate."

Sa ilalim ng mga PSA na ito ay hindi ipinapasa sa konsyumer ang karagdagang gastos sa pag-gawa ng enerhiya, kaya't ang halaga ng kuryente sa Metro Manila ay hindi gaanong tumataas kumpara sa ibang parte ng bansa.

"Alam po namin na ang anumang pagtaas ng presyo ng kuryente ay hindi katanggap-tanggap. Kaya noong nakaraang taon ay hindi kami humingi na rate increase at hindi ipinasa sa mga konsyumer ang dagdag na gastos,"ayon kay SMCGP chairman Ramon S. Ang.

Foundation lauds study << P1

drew Velasco. Researchers College of Pharmacy based in Cavite revealed the finding of their scientific study on narra extracts during a press conference held at Rembrandt Hotel in Quezon City last week.

Professors from the De La Salle College (DSLC) who presided over the press briefing were Dr. Alicia Catabay, Louie Fernando D. Legaspi, Sigfredo B. Mata and Timothy Jay L. Bengala.

They confirmed that the antioxidant properties of the bark and branch wood of the critically endangered narra, the Philippine national tree, has the highest ORAC or Oxygen Radical Absorbance Capacity, which is No. 1 in the country and it is among the top 10 in the world.

ORAC is a method developed by scientists at the National Institute of Health and Aging to measure the antioxidant capacity of different

The ORAC score is also the unit of measure of antioxidants which is the body's natural defense versus harmful compounds that are linked to multiple illnesses, including weakened immunity, diabetes, heart disease and cancer.

At the same time, the study revealed that the ORAC scores of all methods tested displayed similarly high levels of antioxidant potency.

"Indeed, our native trees are precious and they have medicinal value waiting to be tapped. It is a matter of time that cure to various illnesses could be discovered and developed into life-saving drugs that can help save millions of lives," said retired Police Brig. Gen. Reynaldo V. Velasco, chairman emeritus of MTFI. It may be recalled that Gen. Bordado said the two Israeli-made vessels are designed to protect Philippine maritime interests in a rapid and precise manner. "In short, accurate, high performance and quick intercept capability against current and emerging maritime threats," he added. The PN's first two FAIC-Ms were loaded aboard a cargo ship and departed Haifa, Israel in late August. These vessels were formally launched last June 26. Three more vessels are scheduled to be delivered starting this year while the remaining four units will be constructed at the PN shipyard in Naval Station Pascual Ledesma in Cavite City. These 32-meter high-speed vessels are equipped with quick intercept ability, remote stabilized weapons, and short-range missiles that are capable to deliver precision strikes against larger hostiles and high-value targets on land and sea. Four of the FAIC-Ms will be armed with non-line-of-sight (NLOS) missiles with pinpoint accuracy and a range of 25 kilometers while the other four will be armed with machine guns and light automatic cannons. Once deliveries of the FA-IC-Ms are completed, these vessels can interdict surface threats and launch non-line-of-sight missiles safely using the surrounding littoral areas as maneuver space and cover. DOST, NIA-QIMO helps Quirino farmers on processing excess farm produce

Every morsel of food or every piece of vegetable is very important in helping ensure food security, not only for families but also for many communities in the country.
