As part of ongoing U.S.-Philippine cooperation to enhance the Philippines' maritime law enforcement capabilities, the U.S. Coast Guard (USCG) facilitated the first Philippine Coast Guard (PCG)-led Small Boat Operations course from September 5 to 16 in Manila.

With the support and mentorship of visiting USCG instructors, 12 PCG instructor candidates trained 16 PCG students through classroom instruction and at-sea practical exercises to improve their skills in navigation, boat driving, risk management, towing, and man-overboard recovery. This training is part of a series of courses sponsored by the Department of State's Bureau of International Narcotics and Law Enforcement Affairs, with funding support from the U.S. Global Contingency Security Fund, to prepare Filipino instructors to lead

small boat operations training for the PCG. During the course graduation ceremony on September 16, Philippine Coast Guard Fleet Commander Rear Admiral Charlie Q. Rances noted the breadth of the U.S.-PCG partnership. "This is just one of the many training and learning opportunities that INL and USCG extend to the PCG," he said. The USCG Liaison at U.S. Embassy Manila, Commander Bien Decena, added that "This type of technical training among maritime professionals highlights the strong relationship, unity, and likeminded outlook between the Philippine and U.S. Coast Guards." INL and USCG will organize additional training activities with the PCG later this year on various topics, including maritime law enforcement operations and vessel engineering program management.

The activity was held at the Ceremonial Hall of the Provincial Capitol Building with Provincial Administrator for Community Affairs Head Mr. Alvin S. Mojica welcoming the DILG validators as well as the participants. Cavite Governor Juanito Victor C. Remulla said in his message that, "SGLG is a means of validating Cavite province's performance and commitment. It is also a measure of its performance in the past years and

the years to come." Likewise, Vice Governor Athena Bryana Tolentino commented that such validations of governance would give greater impetus to local development thus, encouraging local communities to engage in and sustain capacity building towards excellence and local administration. Mojica also disclosed that this was PGC's first shot at a national validation and expressed his enthusiasm for achieving the recognition due to the hard work and dedication of all employees to attain the goal.

DILG-Cavite Provincial Director Lionel L. Dalope also expressed hope that the NAT validators would recognize the hard work and dedication of Caviteños in public service and the leadership of the governor. The NAT assessment team reviewed and validated the documents in the ten governance areas which include Financial Administration, Disaster Preparedness, Social

Protection and Sustainability, Health Compliance and Responsiveness, Sustainable Education, Peace and Order, Environmental ment, Tourism Heritage Development, Culture and the Arts, Youth Development, **Business-Friendliness** and Competitiveness. helping members who are having a hard time paying their social security contributions. Under this program, a contribution subsidy provider would cover the contributions of self-employed, land-based Overseas Filipino Workers (OFWs), or voluntary members. "A contribution subsidy provider could be a private or government individual or group willing to subsidize the SSS contributions of identified members," Regino explained.

Regino said that the SSS would partner with potential contribution subsidy providers who are generous enough to shoulder the contribution

payments of chosen SSS members for at least six (6) months. They could become a coverage and collection partner of the SSS through an online Certification with Undertaking or a Memorandum of Agreement (MOA). For convenience, contribution subsidy providers can pay the SSS contribution subsidies in any SSS branch with tellering facilities or through an SSS-accredited collection partner.

"We want to provide SSS coverage to workers in the informal sector and land-based OFWs. These workers have the lowest social security coverage in our workforce,

and they are among the most vulnerable sector in times of contingencies," Regino added

The SSS has been reaching out and encouraging them to continue paying their monthly contributions. However, the pension fund fully understands that it is challenging to pay their SSS contributions regularly because of intermittent income and varied work arrangements

As an example, government agencies can subsidize the contributions of their job order workers since they are not covered by the Government Service Insurance

System (GSIS). Regino added that private institutions or multinational companies, as part of their corporate social responsibility, can shoulder the SSS contributions of self-employed informal sector workers or land-based OFWs who lost their jobs due to the pandemic.

"Subsidizing their SSS contributions is the greatest gift that we can give to a fellow Filipino.

It will allow him to gain access to social security benefits which will serve as a cushion that they can rely on in times of emergencies and various contingencies," Regino concluded.

# Classes suspended in NCR, nearby provinces due to heavy rains

Local government units in the National Capital Region (NCR) and nearby provinces successively announced class suspension on Tuesday as the southwest monsoon brought heavy rains in Luzon.

In Metro Manila, afternoon classes in public and private schools were suspended in all levels in Caloocan, Marikina, Las Piñas, Malabon, Navotas, Mandaluyong, Pasay, Parañaque, Pateros, Taguig, Muntinlupa, and Valenzuela.

The suspension, as advised by Valenzuela Mayor Wes Gatchalian, Navotas City Mayor Rey Tiangco, Parañaque Mayor Edwin Olivarez, Malabon City Jeannie Sandoval, and Pateros Mayor Miguel Ponce III, took effect at noon. Meanwhile, Pasay City implemented the suspension from 1 p.m. onwards. The University of the Philippines-Diliman in Quezon City also suspended its classes. Netizens, meanwhile, flooded the comment section of Manila Mayor Honey Lacuna's Facebook post, in which she

## Solar irrigation system to boost Cavite farmers' productivity

Cavite farmers will now have access to sustainable water sources that will improve the quality and quantity of their crops after the Department of Agrarian Reform (DAR) recently turned over two units of solar powered-irrigation system (SPIS) worth PHP6 million each.

Danilo Arnes, Tres Cruses Agrarian Reform Beneficiaries and Farmers Association Inc. president, said tapping solar energy is an environment-friendly way of providing farmers with water for their palay (rice) and high-value crops.

"I was talking to market vendors. They said they would buy our vegetables because it is clean as compared to rain-fed or vegetables that were irrigated from the creek," Arnes said in a news release. "We can plant anything when there is water."

James Arthur Dubongco, DAR-Cavite Provincial Agrarian Reform Program Officer II, said the SPIS offers a viable energy solution for irrigated agriculture.

The project would contribute to rural electrification as it provides a reliable source of energy in remote areas, help reduce energy costs for irrigation, and enable low-emission agricul-

It can irrigate 32 hectares of agricultural lands that will primarily benefit 34 agrarian reform beneficiary households and neighboring farmers.

"SPIS runs on solar energy, so that bringing water to farmlands will be much more affordable than the traditional diesel and gasoline-powered engine pumps," Dubongco said.

During the turnover on September 14, DAR Undersecretary for Support Services Office Milagros Isabel Cristobal asked the beneficiaries to take care of the

"You should take care and be responsible for this project because not all agrarian reform cooperatives are

given the opportunity to be provided with it," she said.

Arnes assured DAR that they will preserve and properly use the SPIS.

The project was implemented under DAR's Climate Resilient Farm Productivity Support and in partnership with the National Irrigation Administration.

The SPIS units are located in Sitio Gugo, Barangay Tres Cruses in Tanza and Barangay Baliwag in Ma-

Secretary Conrado Estrella III previously identified the provision of irrigation as one of the primary goals of DAR. (PNA)

## **New missile boats to help PH Navy** curb transnational crimes

The newly-delivered Acero-class gunboats, also known as the fast attack interdiction craft-missiles (FAIC-Ms), will give the Philippine Navy (PN) the capability to address transnational crimes in the country's territorial waters.

"These fast patrol craft will significantly strengthen the PN in addressing challenges in the maritime realm that include law violations like illegal fishing, foreign vessels' intrusion, smuggling and armed robbery at sea; and transnational maritime threats like piracy, drug smuggling and human trafficking," it said in a statement over the weekend. With two FAIC-Ms now delivered and seven more to arrive within the next two years, the PN said its capability to conduct "fast interception, rapid attack, deliver precision fire and missile strike" has been greatly enhanced. The PN said the FAIC-Ms can perform as a mothership when employed as a task group along with two or more multi-purpose attack craft (MPACs) when conducting swarm tactics. Christened last Sept. 6 were the BRP Nestor Acero (PG-901) and BRP Lolinato To-Ong (PG-902), the first two out of nine vessels acquired from the Israel Shipyards Ltd. for PHP10 billion.

Earlier, Armed Forces of the Philippines (AFP) chief-of-staff, Lt. Gen. Bartolome Vicente Bacarro, said these new ships will greatly enhance the capability of the PN to protect the country's national territory and interests. The PN's FAIC-Ms are based on Israel's Shaldag Mark V class-patrol boats. Three more are slated to be delivered this year while the remaining four units will be constructed at the PN shipyard in Naval Station Pascual Ledesma, Cavite City. Former PN chief, Vice Adm. Adeluis Bordado, said these new FAIC-M vessels are designed to enhance the Navy's capability in addressing threats within the country's "unique archipelagic composition" and protect its maritime interests in a rapid and precise manner. These 32-meter high-speed vessels are equipped with quick intercept ability, remote stabilized weapons, and short-range missiles that are capable to deliver precision strikes against larger hostiles and high-value targets on land and sea. Four of the FAIC-Ms will be armed with non-line-of-sight (NLOS) missiles with pinpoint accuracy and a range of 25 kilometers while the remainder will be armed with machine guns and light automatic cannons. The acquisition of nine FAIC-M units is among the 2019 projects approved by former President Rodrigo Duterte under the Horizon 2 List of the Revised Armed Forces of the Philippines Modernization Program. The notice of award for the FAIC-M project, worth around PHP10 billion, was issued on Jan. 5 last year. These are expected to replace the force of patrol killer medium (PKM) or medium-sized patrol craft. Once deliveries of the FAIC-Ms are completed, these vessels can interdict surface threats and launch non-line-of-sight missiles safely using the surrounding littoral areas as maneuver space and cover. (PNA)

## Single-use plastics banned << P1

The ban includes plastic cups thinner than 0.2 millimeters, plastic drinking straws, plastic spoons, plastic forks, plastic knives, plastic coffee stirrers, and plastic labo and thinnedfilmed sando bags thinner/ lighter than 15 microns.

Officer PPA Charge-General Manager Francisquiel O. Mancile stressed that all port managers across its 25 Port Management Offices must strictly impose the directive embedded under PPA Memorandum Circular No. 11-2021. He added that this will also go hand in hand with the theme of the 2022 National Maritime Week Celebration: "New Technologies for Greener Shipping".

"PPA already has an existing ban on single-use plastics. Since last year, we are not only banning the use and entry of such plastics in the ports but also in all facilities and offices under the agency," Mancile said.

"While we do not impose any fine or penalty to erring passengers, stakeholders, and employees, we are confiscating these kinds of materials for proper disposal," Mancile added.

PPA Memorandum Circular No. 11-2021, meanwhile, follows the National Solid Waste Management Commission Resolution No. 1363 dated 12 February 2020 directing a ban on unnecessary use of single-use plastic products in government agencies and is seen as a major leap to reduce the use of single-plastic items from polluting waterways, kill marine life and further increase the country's solid waste.

Aside from this, PPA has also earlier partnered with the World Wide Fund for Nature (WWF)-Philippines on the same initiatives involving three PPA

#### ports—the North Port, Port of Batangas, and Port of Cagayan de Oro—in a bid to reduce plastic leakage at the said ports by 50% by 2023. The Maritime Industry Authority (MARINA) and the Philippine Coast Guard (PCG), which are also part of the three-pronged maritime sector of the Department of Transportation,

also expressed readiness to impose similar initiatives in their areas of jurisdiction.

The PCG said they will levy heavy fines and penalties to their erring personnel who will be found violating the ban. At the same time, the MARINA will look into further strengthening the regulation imposed on local ships. (PPA/PIA-NCR)
