Cavite Strengthens MSME Programs Through Unified Development Plan

Trece Martires City, December 4 — The Provincial Government of Cavite took a major step toward inclusive economic growth by bringing together key stakeholders to align micro, small, and medium enterprise (MSME) programs with the national MSME Development Plan 2025-2028.

The consultative meeting, titled "Forging Synergies for Inclusive Growth," was organized by the Office of the Provincial Cooperatives Development Officer (OPCDO) at the New Provincial Government Center. A total of 48 participants from 32 agencies, including local government units, provincial offices, national agencies, and non-government organizations, joined the day-long event.

Myrachel P. Cuadra, Officer-in-Charge of OPCDO, highlighted that meaningful MSME growth is best achieved through inter-agency collaboration. Support messages came from Sheryll S. Loyola, Chairperson of the Provincial Government of Cavite Employees and Community Multi-purpose Cooperative, and Lilibeth R. Chavez, OIC Provincial

1 Cavite Extension and upgrade its automated fare collection system.

House Committee on Appropriations Chairperson Rep. Mikaela Angela Suansing said the funds would mainly come from

reductions in the budgets of two foreign-assisted projects: the Metro Manila Subway Phase 1 and the North-South Commuter Railway System, each reduced by P1.8 billion. "We really don't want to touch projects under foreign-assisted projects, but this realignment was requested by Transport Secretary Banoy Lopez himself," Suansing explained.

Of the total, P2 billion will go to the LRT1 Cavite

Extension common station, P1.04 billion to improve the fare collection system, and P614.89 million for the operation and maintenance of the Metro Rail Transit (MRT).

Sen. Sherwin Gatchalian emphasized that the construction of the common station has long been overdue and that Secretary Lopez aims to begin the project by 2026. He also highlighted that modernizing the fare system will ensure convenience for commuters, preventing a return to cash payments if funding is delayed. Suansing added that completing the common station is critical to connect MRT7 with MRT3 by early 2027.

Director of DTI Cavite, who both emphasized sustainable and inclusive MSME development. The meeting included a presentation of the national MSMED Plan 2025-2028 by Susan Mae Salonga, Assistant Director of the Bureau of Small and Medium Enterprise Development-DTI, followed by discussions on how to translate national strategies into local initiatives. residential projects -- priced below prevailing market rates for comparable units -- would be developed, placing them within the socialized housing range while offering amenities typically found in higher-priced developments.

The units are expected to be completed within two to three years. The partnership covers two initial project sites in Dasmariñas, Cavite, comprising 4,185 housing units in the Dasmariñas-Salitrán site and 2,958 units in the Dasmariñas-Paliparan site.

The developments are expected to support the national government's push to scale up socialized housing through increased private sector participation and faster project delivery.

Department of Human Settlements and Urban Development (DHSUD) Secretary Jose Ramon Aliling, who chairs the Pag-IBIG Fund Board of Trustees, said the partnership is designed to expand the supply of socialized housing while enabling faster construction and more accessible pricing for Filipino families.

"By strengthening partnerships that increase housing supply, we help create more opportunities for Filipino workers and their families to move closer to homeownership. We hope this will further stimulate private sector participation in building affordable homes," he added.

Under the partnership, Pag-IBIG Fund will invest up to PHP10 billion through a subscription to preferred shares in the project company.

The investment will be released in three tranches:

PHP5 billion for the first tranche and PHP2.5 billion each for the second and third tranches.

Pag-IBIG Fund Chief Executive Officer Marilene Acosta said the investment advances the agency's mandate of expanding homeownership opportunities while ensuring prudent management of members' savings.

"By supporting the development of thousands of housing units while securing investment returns, we strengthen Pag-IBIG Fund's capacity to serve more members, grow their savings, and promote homeownership," she added. (PNA)

relief from unresolved estate issues while addressing long-standing structural challenges in the system. Under House Bill No. 6614, an amendment to the Tax Amnesty Act, heirs of decedents who died on or before December 31, 2024, would have more time to settle estate taxes without facing surcharges, interest, or penalties.

"This is about correcting a long-standing structural problem. Many families want to pay and settle their papers, but they can no longer bear the weight of the penalties and the process," Mercado-Revilla said. She explained that unpaid estate taxes often block families from availing previous amnesty programs. "Unknown to many, countless Filipino families struggle to update

or fully benefiting from inherited assets.

The lawmaker also noted that pandemic disruptions, delayed government processing, and incomplete documentation have prevented many heirs from availing previous amnesty programs. "Unknown to many, countless Filipino families struggle to update

their estates because of steep penalties and burdensome documentary requirements," she added.

Mercado-Revilla stressed that extending the amnesty will encourage voluntary compliance, unlock idle properties, and strengthen land ownership security, particularly in provinces where informal land ownership is common. HB No. 6614 passed the House with 280 votes in favor on December 16 and is now awaiting Senate action.



PETITION

COMES NOW, Petitioner, by the undersigned counsel and unto this Honorable Court most respectfully alleges that:

PREFATORY STATEMENT

"Unjustified absence from the marital home for decades may be considered as part of the totality of evidence that a person is psychologically incapacitated to comply with the essential obligations of marriage. - LEONEN, SAJ.

"The husband "must not be forced to stay in a loveless marriage, and his marriage to (his wife) must be voided."

1. The Petitioner, **MICHAEL ANTHONY MACAM MAITIM**, is of legal age, Filipino, married, with residence address located at **Block 45 Lot 3 Madrid St., Hacienda La Joya Subd., Brgy. Buhay na Tubig, Imus City, Cavite**, where he may be served with summons and other legal processes of this Honorable Court.

2. The Respondent, **ALMA MARANTAL MARFIL**, is of legal age, Filipino, married, with residence at **# 78 Balubad St., Nangka, Marikina City** where she may be served with summons and other legal processes relative to this instant case.

3. Sometime in the year 2000, herein Petitioner and Respondent came to know each other in their workplace, Merriam Webster Bookstore Araneta Center Cubao, Quezon City. Respondent was one of the staff in said company and petitioner was likewise one of the employees. It is where the dating relationship started and the formal serious relationship thereafter arose.

4. Respondent introduced him to her family members and in fact went to their place in Albay. It was also at that time that a problem occurred in the respondent's family that it led for the mother of the latter to beg for petitioner to take with him the respondent right away, a behavior which the petitioner until now finds so odd and unusual. Thus, it forced petitioner to look for a place near their workplace considering that he was just renting a place to stay for himself.

5. Eventually they found a small apartment to rent in Angono, Rizal. It also led for respondent to find another work in Shangrila Plaza, Edsa Mandaluyong City. Other odd behavior exhibited by respondent came to fore afterwards.

6. During those times, petitioner noticed that the respondent was being drop off by her male boss or manager who has a car

from work and where the former was waiting for her. Their stay in said place did not last long considering its relatively higher rental fees and expenses. So, it led them to transfer from one place to another and there was a time that they even stayed in one of the siblings of the petitioner.

7. Owing to the pressure coming from the petitioner's aunt, that they did not like the idea that they were living under the same roof without the benefit of a marriage, they decided to hurriedly plan to get married. Thus, they finally had their **civil wedding in Imus, Cavite on June 28, 2001**. A copy of their Certificate of Marriage issued by the Philippine Statistics Authority (PSA) is herein attached and marked a **ANNEX "A"** and the copy issued by the Local Civil Registry (LCR) is herein marked as **ANNEX "B"**.

8. After the wedding the couple opted to stay in the house of the herein petitioner. Respondent decided to take TESDA courses for her to work in beauty salons. It led for respondent to eventually work in a Salon owned by petitioner's aunt.

9. The couple attempted in vain to bear a child but it proved futile. The petitioner noticed also that the respondent looked lonely and sad. Thereafter, respondent revealed the shocking truth that according to her, she was not actually inclined to marry petitioner and that it was just by reason of her mother and petitioner's aunt that she was pressured to enter into the marriage. The revelation severely affected the petitioner.

10. The relationship further became more problematic and soured after the petitioner became a full pledged seafarer in 2003. They became both "cold" with each other. So that in the year 2005 they began their de facto separation and also broke their communications altogether. The respondent returned home to her parents' house in Marikina City whereas complainant remained in Imus, Cavite. In other words, it has been almost twenty (20) years now that the couple has been in this state of a de facto separation. Respondent and complainant, in effect, pursued their own lives since then without them even attempting to showed signs of reconciliation.

On the Psychological Incapacity

11. The respondent's responsibility as the petitioner's wife is to be the latter's strength and shoulder to lean on whenever there were major decisions and things to be dealt with, but the respondent did not show keen interest in any of those but only on things/matters intended for herself alone. Respondent has shown an undeniable pattern of such persistent failure to be a present, loving, faithful, respectful, and supporting spouse.

12. Respondent's lack of love, intimacy and support for petitioner and his endeavors affected their communication, time spent together, as well as their intimacy. They never even lived together as husband wife in the truest sense.

13. It can be said therefore that the herein parties' acts, and omissions indicate that they BOTH failed to provide each other with love, companionship, respect, mutual help, support and care as commanded by law in order to have a successful married life.

14. The parties' inability to discharge the essential obligations of marriage is grave and incurable, as the acts of constituting the same are habitual, persistent, unchanging and of enduring nature.

15. The failure and/or inability of the parties to perform the essential marital obligations as shown in the foregoing paragraphs most certainly render the marriage between the parties null and void on the ground of their psychological incapacity under the provisions of **Article 36** of the Family Code.

16. In a fairly recent case, the Court pronounced that *"psychological incapacity is not a medical but a legal concept. It refers to a personal condition that prevents a spouse to comply with fundamental marital obligations only in relation to a specific partner that may exist at the time of the marriage but may have revealed through behavior subsequent to the ceremonies. It need not be a mental or personality disorder. It need not be a permanent and incurable condition."* (Italics supplied).

17. To sum up the married life of the parties, the same was a life full of pain, agony, stress, anguish, depression, misery, and psychological torture on the part of the petitioner or perhaps to the respondent as well. The acts and omissions and deliberate refusal of respondent to love and respect him as a husband, and her utter insensitivity and complete abandonment of her basic and essential marital obligations towards petitioner squarely fall within the purview of Psychological Incapacity under Article 36 of the Family Code.

The Psychological Evaluation Report

18. In order for the herein petitioner to assess the status of his marriage with the respondent he secured the services of Dra. SHEILA MARIE P. ORALLO, an expert on the matter, so that as per the results of the evaluation dated September 05, 2024, the following conclusions/recommendations were made:

With due consideration to the above findings, and since reconciliation would only cause mental and emotional distress on the Parties, it is then recommended that the marriage between the Petitioner and the Respondent be declared null and void on the account of the Parties' psychological incapacity pursuant to Article 36 of the Family Code that is grave, severe, permanent and incurable, as well as deeply ingrained in their personality structures. (Emphasis added)

19. Reconciliation between the petitioner and respondent is no longer possible due to acts and omissions of the latter or maybe both of the herein parties considering that they were already in a de facto separation for more than twenty (20) years already.

20. So now, to deliver petitioner from the ordeal of a marriage that had brought him nothing but pain and grief and to free from the eternal embarrassment and inequity of being bound by marriage to an absentee wife, Petitioner is now constrained to seek this ultimate recourse of declaring his marriage a NULLITY.

21. That petitioner, in compliance with the jurisdictional requirements pursuant to **A.M. No. 02-11-10-SC (2003)**, hereby submits the following, which likewise form as integral parts of this Petition:

- 1.) **Sworn Certification of residency** (with house location sketch) issued by the Office of the Punong Barangay (**Annex "E"**);
- 2.) **Sworn statement of counsel** of record (that he has personally verified petitioner's residency and that the petitioner had been residing thereat for at least six (6) months prior to the filing of petition) (**Annex "F"**);
- 3.) **Proof of Billing under the Petitioner's name** (**Annex "G"**)

22. The following are the names of the **intended witness/es** and **summary** of their testimonies:

1. MICHAEL ANTHONY M. MAITIM

- To prove the material allegations in the Petition and identify the existence of the documentary evidence/exhibits.
- To prove and show that petitioner is entitled to such reliefs as prayed for.

2. REBECCA CALAUNAN

- to corroborate the material allegations of the Petitioner and to identify certain documentary evidence if needed.
3. The Expert witness, **Dra. DR. SHEILA MARIE O. ORALLO** - to testify on the conducted **Psychological Evaluation**, and for her to identify the related documentary exhibits.

23. Whereas the list of documentary exhibits/ evidence is the same as marked in the foregoing paragraphs (i.e., **Exhibits "A" - "H"**).

Copies of the documentary evidence and **Judicial Affidavit/s** **Sinumpaang Salaysay** of the aforementioned witness/es are attached and made as integral parts hereof, the latter herein marked as **Annex "I" and series**, if deemed necessary.

PRAYER

WHEREFORE, in view of the foregoing, Petitioner prays that after due notice and hearing, it is respectfully prayed that the Honorable Court render judgment as follows:

1. Declaring the marriage between the petitioner and respondent null and void ab initio under the provisions of **Article 36** of the Family Code of the Philippines. The foregoing is without prejudice to the application of Articles 50 and 51 of the Family Code, if applicable under the premises.

2. Directing the **Civil Registrar of City of Imus, Cavite** to record or annotate in the appropriate official registry thereof, the judgment of the Honorable Court declaring the marriage of the Petitioner and Respondent as null and void.

3. Adjudicating all other legal effects of the decree of nullity of marriage.

Petitioner prays for such other relief just and equitable in the premises.

Motorists can expect a smoother ride this holiday season as Metro Pacific Tollways Corporation (MPTC) announces toll-free hours on key expressways, including the North Luzon Expressway (NLEX), Subic-Clark-Tarlac Expressway (SCTEX), Cavite-Laguna Expressway (CALAX), and Manila-Cavite Expressway (CaviteX). The toll relief will be available during the following periods: from 10 p.m. on December 24 to 6 a.m. on December 25, and from 10 p.m. on December 31 to 6 a.m. on January 1, 2026. Additionally, the MPTDriveHub app allows users to top up their Easytrip RFID accounts, access roadside assistance, and receive real-time traffic updates. With these measures in place, holiday travelers on major expressways can enjoy less stress and faster trips during the festive season.

Historic Pulpit Collapses in Maragondon Church



MARAGONDON — A 300-year-old pulpit at the Parroquia de Nuestra Señora de la Asuncion in Maragondon collapsed recently, shocking parishioners and heritage advocates alike. The pulpit, considered a significant cultural and religious artifact, had been a centerpiece of the centuries-old church.

According to church authorities, an investigation conducted in coordination with the National Commission for Culture and the Arts (NCCA) revealed that the collapse was caused by an internal structural failure in the Tornavoz, or sound bar support, which had weakened over time. Despite its age and historical importance, the pulpit had been regularly maintained, but the failure was sudden and unexpected.

Local government units and church agencies quickly mobilized to assess the damage. The Maragondon Tourism Office, NCCA, and the Diocese of Imus have been working together to ensure that the historic structure can be restored and conserved properly. Officials emphasized that their goal is to return the pulpit to its original condition while preserving its historical integrity.

The pulpit, which had stood as a symbol of Maragondon's rich heritage for centuries, played a key role in the church's religious services and local celebrations. Many residents have expressed concern over the incident but remain hopeful that restoration efforts will be successful.
