#### 49 gov't infra projects exempted from poll ban on public works

A total of 49 government infrastructure projects such as railways, hospitals and airports are exempted from the election ban on public works in connection with next year's midterm polls.

In a certificate of exception signed by Commission on Elections (Comelec) Chairperson George Garcia on Dec. 11 but made public on Friday, the construction of the projects will continue as they are not covered by the ban provided under the Omnibus Election Code and in relation to a resolution from the poll body.

The infrastructure projects are the University of the Philippines (UP)-Philippine General Hospital Manila (Cancer Center Project) and Diliman projects, UP-

# From mythical giant to resilient vendor: The journey of Romeo Dillo

Standing at an imposing 7'3", Romeo "Raul" Dillo once had a promising career in basketball but was cut short by a knee injury, prompting him to enter the show business industry.

Known for portraying larger-than-life mythical creatures in Filipino fantasy films, Raul became a household name for his roles as "kapre" and the mysterious "tikbalang." His deep voice and extraordinary stature captured the imagination of audiences and solidified his status as an icon of local folklore.

But life off-camera took a different turn. Today, Raul can be found navigating the bustling streets of Imus City in Cavite province, not as a mythical giant but as a humble "longganisa" (native sausage) vendor. His story is one of resilience, humility, and reinvention—a testament to the power of hope in the face of adversity.

Raul lives with his wife, Helen, and their two children in a modest apartment.

After stepping away from the glitz and glamour of show business, he faced the harsh reality of finding a stable livelihood. Initially, he tried his hand at cooking and selling "lugaw" (porridge) and pancit, which were well-received by the community.

However, the physical demands of running a food business began to take a toll on his health.

The pandemic in 2020 brought one of Raul's most challenging moments when he was hospitalized. During this time, he relied heavily on the support of friends and his community.

Upon his recovery, a friend entrusted him with the capital to start a small longganisa business, igniting a spark of hope. "Wala po talaga akong pang puhunan, nagkaroon lang ako ng kaibigan na nagtiwala sa akin (I don't really have any capital, I just had a friend who trusted me)," he recounted.

While Raul humbly admits he is not a natural salesman, his determination keeps him going. Recently, his story gained attention in social media, where he was spotted selling longganisa on the busy streets of Imus.

The viral post reached the local government, which encouraged him to apply for a livelihood grant from the Department of Labor and Employment (DOLE).

DOLE-Calabarzon Regional Director Roy Buenafe sought Raul to provide him with an opportunity to rebuild his life.

Last Dec. 4, Raul's efforts bore fruit when the agency awarded him with a meat processing package worth PHP29,915. This included a meat grinder and raw materials, enabling Raul to produce his own homemade longganisa.

Raul's journey from being a character actor to a resilient entrepreneur is a poignant reminder of the strength it takes to rebuild one's life. Grateful for the support of his friends and the government, he is determined to make his longgani-

# DA chief warns rice importers involved in profiteering

The Department of Agriculture (DA) on Thursday warned importers who are allegedly selling branded rice at an "unreasonable" profit mar-

In an ambush interview at the sidelines of the DA's joint market inspection with the Department of Trade and Industry (DTI), DA Secretary Francisco Tiu Laurel Jr. said he has monitored high retail prices of branded rice which show possible "profiteering" of some rice importers.

"Alam niyo naman dati akong negosyante kaya kaya kong himayin talaga ng masinsinan ito at makita ko iyong landed cost, makita ko iyong margin nila na unreasonable. Susugpuin natin itong isyung ito (You all know I was a businessman before, that's why I can really dig deep into this and assess the landed cost, will eliminate this issue)," he

Tiu Laurel said he would immediately call for a meeting and order the listing of branded rice with spiking prices in local markets, to be followed by tracing of brand owners or importers.

He reiterated that the profit margin should only be at a PHP5 to PHP7 per kilogram, for a reasonable range of branded rice at PHP47/kg to PHP50/kg.

"Talagang we'll drill down dito sa mga ganitong brand na may practices na medyo sobra naman yun. Kung PHP42 (landed) cost mo, ibebenta mo PHP62, that's 50 percent na patong (We will drill down in these brands with practices that are somehow excessive. If your landed cost is PHP42/kg, you will sell at PHP62, that's a 50 percent markup)," he said.

taged sector. In terms of KNP expansion, Tiu Laurel said he already asked the help of Department of the Interior and Local Government (DILG) Secretary Jonvic Remulla to expand the implementation of Rice for All and P29 program outside Metro Manila.

"Kakausapin niya lahat ng mayors sa Metro Manila and mga karatig na mga lalawigan ng Metro Manila... para kausapin na lahat ng mga markets, mga palengke na lalagyan na ng (He will talk with all the Metro Manila mayors and nearby provinces... to talk with all the markets to put up) Kadiwa ng Pangulo Rice for All," he said.

These areas include the provinces of Pampanga, Bulacan, Rizal, Laguna, and Cavite.

The DA chief likewise said that the call of some lawmakers for a "rice emergency" may help address persistent high retail prices.

Also covered by the exemption are the High-Capacity Bus System in Iloilo City, Establishment of Hemodialysis Centers in Iloilo Provincial and District Hospitals, Ramon Newport Project, Redevelopment of General Santos City Public Market Project, Bislig City Bulk Water Supply, Bislig City Septage Project, National Single Window Through An Integrated Trade Facility Platform, Comprehensive Digital Housing Platform Project, and Special **Products** Automated Revenue Collection System (SPARCS) Project PRA Digitalization Project.

"This Certificate of Exception shall not be construed as a waiver on the part of the Comelec to prosecute for other election offenses such as Sections 104; 261 (o), (v) and (w) of the Omnibus Election Code, nor shall it exempt the certificaterecipient from complying with the provisions of the Commission on Audit in its Circular No. 2013-004," the poll body said.

"Any alteration in this document shall invalidate this Certificate and the use of an altered document constitutes offense," it added. (PNA)

## NBI ordered to name individuals << P1

Representative Janette Garin made the motion ordering the NBI to identify individuals or organizations responsible for price hikes.

"With this, Mr. Chair, will this august body allow me to put forward a motion to direct the [NBI] to investigate [both ways]—from the retailers to the middleman to the wholesalers, or wholesalers papunta rito sa mga middleman papunta sa mga retailers (to middlemen to retailers) —so we can specifically identify the responsible people in terms of price manipulation. I so move, Mr. Chair," Garin

The motion seconded by Cavite 2nd District Rep. Lani Mercado-Revilla and approved by Albay 2nd District Rep. Joey Salceda, who chairs the joint panel. Salceda directed the NBI to investigate the entire supply chain to expose manipulative practices.

The Philippine Competition Commission (PCC) highlighted vulnerabilities in the rice supply chain, particularly among vertically integrated entities and middlemen.

During interpellation, Garin asked Agriculture Secretary Francisco Tiu Laurel Jr. what agency oversees these middlemen.

Laurel said there is no agency specifically tasked with monitoring middlemen.

Garin attributed the issue to the enactment of the Rice Tariffication Law in 2019, which removed the National Food Authority's (NFA) power to stabilize rice prices through direct

"Natanggalan ng power ang NFA na magbenta ng bigas. Bakit ito importante? Garin highlighted that some middlemen exploit to control access of legitimate wholesalers, driving prices

"At 'yung retailer ay tila hindi nabibigyan ng direct na linya papunta sa totoong wholesaler kasi kontrolado nito ang mga middleman na ito (Retailers appear unable to connect directly to legitimate wholesalers because these middlemen control access)," she said.

She said the NBI

investigation is expected to reveal whether middlemen's actions constitute economic sabotage or profiteering.

The Quinta Committee is composed of the House Committees on Ways and Means, Trade and Industry, Agriculture and Food, Social Services, and the Special Committee on Food Security.

Despite reduced tariffs on rice imports, prices have remained high, ranging from PHP55 to PHP60 per kilogram.

Lawmakers suspect collusion among importers, traders, and middlemen.

Marikina Rep. Stella Quimbo, earlier, claimed that importers and traders collectively profited a staggering PHP13 billion after rice import tariffs were slashed from 35 percent to 15 percent under Executive Order 62. (PNA)

Under a rice emergency, the National Food Authority (NFA), under the amended Rice Tariffication law, may sell its stocks to the public to alleviate the impact of spiking rice prices in the country.

"If declaring a rice emergency allows us to sell NFA's nearly 6 million bags of rice at flexible prices to the public, then that's definitely a good move," Tiu Laurel said. (PNA)

# Barangays in Cavite given executive course in promoting sustainable peace

DASMARIÑAS CITY. Cavite (PIA) – The role of barangays in fostering lasting peace in the community is highlighted as a university in Cavite launched the Barangay Peace and Conflict Transformation (BPACT) Executive Course.

Helmed by the ninth batch of Master in Sustainable Leadership and Governance students of De La Salle University in Dasmariñas, the BPACT Executive Course aims to provide barangay officials and Sangguniang Kabataan leaders with vital skills in conflict resolution, mediation, and peacebuilding.

The program likewise seeks to empower grassroots leaders to foster inclusive, harmonious, and resilient communities.

Professor Rommel Mazo, Director of the university's School of Governance, stated that BPACT is a 13 to 15-week highly specialized course designed to support the barangay justice administration overseen by the Department of the Interior and Local Government (DILG).

"Peace is essential in development. Progress cannot occur without peace. The state exists fundamentally to promote peace and order. Without peace and order, there is no development, no culture, no civilization," Mazo said.

Engr. Danilo Nobleza, Provincial Director of DILG Cavite, recognized the importance of the academe in its mission to empower barangays in maintaining peace and promoting development within their communities.

"This program is highly significant as we have seen how an academic institution was given the opportunity to offer a program that addresses the skills and knowledge needed for serving our communities,"

Nobleza assured that the interior department will fully support the BPACT Executive Course by offer-



ing technical assistance and advocating for its adoption in other local governments. For barangay and Sangguniang Kabataan officials, the inaugural BPACT course is a valuable learning opportunity designed to enhance their conflict resolution skills and prevent disputes from escalating to the courts.

Ariane Agustin, a Sangguniang Kabataan member in Tanza, Cavite urged fellow SK officials to support this initiative as part of their responsibility to inspire other youth to be involved in local governance.

"To my fellow SK officials, let's support the BPACT program. We need this because as youth leaders, we are expected to fulfill our duty and inspire the youth to participate in the community."

Matde Blancaflor from Barangay Biwas, Tanza stated the course will better equip them to resolve cases and disputes at the barangay level and prevent them from being elevated to higher au-

"It provides guidelines on how cases are processed at the barangay level, helping reduce conflicts and prevent issues from escalating to the courts when they can be resolved within the barangay."

Aligned with the principles of Conflict Sensitive and Peace Promotion (CSPP) from the Office of the Presidential Adviser on Peace, Reconciliation, and Unity (OPAPRU), the BPACT Executive Couse also supports the United Nations' Sustainable Development Goal (SGD) 16, which focuses on promoting peace, justice, and strong institutions.
