In a move set to reshape its energy strategy, the First Cavite Industrial Estate (FCIE) has selected MPower, a subsidiary of the Manila Electric Company (Meralco), to manage the electricity supply for its facilities under a pioneering government program. This partnership enrolls the 150 hectare industrial park in the Energy Regulatory Commission's Retail Aggregation Program. The initiative

## **Bacoor City Teams Up** With Local Lawyers to Offer Free Legal Help



BACOOR CITY, Nov. 11, 2025 - The City Government of Bacoor has joined forces with the Integrated Bar of the Philippines Cavite Chapter to provide free legal assistance to its less fortunate residents. The partnership was formalized with a Memorandum of Agreement signed on Tuesday at the Strike Conference Room.

Mayor Strike B. Revilla and IBP Cavite Chapter President Atty. Jessie A. Salvador led the signing ceremony, which was also attended by other IBP officers and organized by the City Legal Office under Atty. Kim Nyca Lofranco.

This new program will offer free legal consultations and advice to qualified indigent beneficiaries. The primary goal is to help resolve legal disputes early, potentially avoiding the need for costly and lengthy court proceedings.

Beyond direct legal aid, the agreement includes plans for IBP lawyers to host an informational segment on Strike TV. The city will also establish new districts for the People's Law Enforcement Board to handle complaints against police officers.

Mayor Strike highlighted the initiative's core purpose, stating it is about making legal knowledge and resources accessible to every citizen.

the storm's heavy rains and strong winds.

According to the latest reports, the typhoon has affected 12,184 families, 44,733 individuals, across various cities and municipalities in the province. Officials have confirmed no casualties.

Governor Remulla emphasized the provincial government's commitment to a swift and efficient response. "The safety and welfare of Caviteños remain our top priority," he stated.

Preparations began even before the typhoon entered the Philippine Area of Responsibility. The Provincial Disaster Risk Reduction and Management convened Council November 7 for a Pre Disaster Risk Assessment with local and national agencies. Following national directives, preemptive

evacuations were carried

out in high risk areas to ensure resident safety.

The province's Emergency Operations Center is operating 24/7, with all response clusters on full alert to monitor the situation and coordinate with local government units.

Relief operations, managed by the Provincial Welfare Social and Office, Development started on November 9. Aid

packages containing food and essential items have already been distributed to families in Ternate, Maragondon, Silang, and Naic. The provincial

government continues to mobilize its resources for sustained support. The Disaster Risk Reduction and Management Office remains on heightened alert for further monitoring. Residents are advised to stay vigilant and follow updates from official government

#### Provincial Government Delivers Free Health Services in Noveleta

NOVELETA, Cavite - The Provincial Government of Cavite provided free medical and dental care to the local community of Barangay San Rafael III here on November 6, 2025. This initiative is part of the province's ongoing mission to ensure all Caviteños have access to essential health services.
