culture sector in component cities and first-class municipalities will receive an additional ₱20, raising their daily minimum wage from ₱520 to ₱540.

Meanwhile, non-agriculture workers in fourth, fifth, and sixth-class municipalities will receive a ₱30 increase, elevating their daily minimum wage from ₱420 to ₱450.

The Wage Board added that workers in the agriculture sector in first-class municipalities will receive an increase of ₱35, adjusting their daily minimum wage from ₱465 to ₱500.

"These adjustments follow the initial tranche implemented on September 30, 2024, and are part of the government's ongoing efforts to ensure fair compensation for workers in the region," the Regional Tripartite Wages and Productivity Board Calabarzon (RTWPB IV-A) said

in a statement. The RTWPB IV-A advised employers to comply with the new wage rates to avoid penalties, while workers are encouraged to stay informed about their updated compensation entitlements. (RBF, FSC, PIA4A)

worth of SSS contributions with corresponding penalties while 45 employers got a stern warning for not registering their businesses with the SSS. "Employees rely on their SSS benefits for financial security in times of need. Employers' failure to register their businesses and remit their workers' contributions not only violates the law but it also deprives their

employees with the benefits they rightfully deserve," Igharas said. He underscored that the RACE Campaign shows SSS' commitment to enforce the law so they can protect the rights of workers in the region. "Employers must understand that timely and accurate contribution remittance is more than a legal obligation but a moral responsibility." He explained

that SSS is giving these delinquent employers 15 days to coordinate with their respective branch offices and settle their contribution delinquencies to avoid any legal consequences, noting that business owners can take advantage of existing condonation programs and flexible payment terms.

"We are sending a clear message that SSS will take

necessary actions to uphold the welfare of Filipino workers. We urge all employers to comply voluntarily and work with us in building a more secure future for their employees," he added.

He concluded that failure to comply may result in imprisonment of six years and one day to 12 years and or a fine ranging from ₱5,000 to ₱20,000.

Alyansa bets eye job generation, wage hike push amid rising costs

Alyansa Para sa Bagong Pilipinas (ABP) senatorial candidates on Friday reaffirmed support for the proposed across-the-board minimum wage hike, which is gaining momentum in Congress.

In a press conference during the administration slate's campaign sortie at the Ynares Center in Antipolo City, ACT-CIS Party-list Rep. Erwin Tulfo noted that both houses of Congress have already filed wage hike proposals in response to public clamor over the rising cost of living.

He said a proposal for a PHP200 increase has been approved in the House of Representatives while a PHP100 hike has been approved in the Senate.

"Pero kailangan doon sa bicam (Bicameral Conference Committee) iko-combine 'yon. Ano ba talaga 'yong PHP200 o PHP100? (But it needs to be combined in the bicam. What exactly will be approved, the PHP200 or the PHP100?)," he added. The proposed wage increases come amid

mounting pressure from labor groups for immediate relief, especially in vote-rich provinces like Rizal, where many workers are part of the manufacturing, retail, and informal sectors. On job generation and livelihood programs, especially for youth and informal workers, former Senate president Vicente Sotto III called for increased funding directly allocated to provinces. "Kailangan siguro magkaroon 'yong sinasabi namin nila (former) Senator (Panfilo) Lacson before na additional funding directly for livelihood and agriculture sa iba't ibang probinsya... every province, at hindi basta't probinsya... let say na malapit sa administrasyon

(Maybe we need to have

what Senator Lacson and I were talking about before, additional funding directly for livelihood and agriculture in the provinces... every province and not just any province... let's say those that are close to the administration)," Sotto said.

Former Interior Secretary Benjamin Abalos Jr., on the other hand, addressed the issue of resettlement and job access for informal settlers.

Citing his experience, Abalos said when he transferred informal settlers to Cavite, one requirement for the new place is that it should be one jeepney ride away from people's workplace.

"We could build an area by building a community," he said. (PNA)
