other possession or sale of these devices is against the law. "Our police force is strictly guarding against illegal activities such as the sale and use of unauthorized electric meters," PCol Red stated. "Let us cooperate to avoid danger and maintain the order and safety of our community."

The penalties violating this law severe. Offenders may face imprisonment from six years and one day to 12 years, and a fine between ten thousand and twenty thousand pesos. The law also requires the confiscation of all involved electrical materials.

Director Red further cautioned that those found guilty could also have their power service disconnected and be permanently banned from obtaining future electrical connections.

The public is urged stay vigilant and report any individuals or establishments involved in the illegal trade, tampering, or installation of electric meters. Reports can be made to the nearest police station or via the official Cavite Police Provincial Office Facebook page.
