Ms. Kyla Anika Ligeralde, Social Welfare Officer II from the Protective Services Division of the Department of Social Welfare and Development (DSWD) Region IV-A, served as the resource speaker for the event. She provided an in-depth discussion of Republic Act 11862, the Expanded Anti-Trafficking in Persons Act of 2022, and Republic Act 11930, which targets child sexual abuse and exploitation. Her presentation emphasized strengthened legal mechanisms and protective these laws to combat human trafficking, protect victims, and prosecute offenders.

In addition to the legislative updates, the campaign also tackled the trends and current status of trafficking in persons (TIP) cases in Cavite. Participants were informed of the growing concern regarding human trafficking incidents in the province and the critical need for stronger preventive measures. The discussion underscored how modern trafficking schemes are evolving and how local authorities are adapting their strategies to combat these developments.

Ligeralde also Ms. discussed the programs and services available for TIP victim-survivors, providing a comprehensive overview of the support systems in place such as rescue operations, legal assistance, psychosocial counseling, medical aid, and reintegration programs.

Lastly, the referral networks and pathways for TIP cases were detailed, outlining the coordinated approach between local units, government enforcement agencies, and social welfare offices. This referral system ensures that victims receive the necessary care and support throughout their journey to recovery, from initial rescue to longterm rehabilitation.

Following the informative session, an open forum was facilitated, allowing participants to ask questions, share insights, and discuss their experiences in addressing traffickingrelated issues in their respective communities. The forum fostered a productive dialogue among council members and attendees, highlighting the importance of collaboration in the fight

against human trafficking. The event reaffirmed the commitment of the Provincial Government of Cavite to protecting citizens, especially women and children, from exploitation and abuse. Through continued advocacy and legal enforcement, Cavite is dedicated to ensuring a

JUDGMENT

This case arose out of the Complaint filed by Phoenix Ready Mix Concrete Development and Construction, Incorporated, for collection of sum of money, seeking the judgment be rendered directing defendant One Mega Builders Construction Corporation to pay the following: Nine Hundred Forty Seven Thousand Five Hundred Sixty Pesos and Ninety Centavos (Php 947,560.90), representing the total outstanding obligation for the purchases, as of 16 February 2017, and interest of eighteen percent (18%) per annum, as stipulated in the Contract Proposal and Agreement, from 20 April 2016 until full payment; twenty-five percent (25%) of the total amount due, as attorney's fees, and appearance fee of Three Thousand Pesos (Php3,000.00), for every hearing attended by counsel, and; cost of suit.

It was originally assigned to the Regional Trial Court of Imus City, Cavite Branch 20, but pursuant to Administrative Order Number 180-2019, dated 2 September 2019, it was re-assigned to this court. The case was initially dismissed, for failure to prosecute.

With the plaintiff's filing of its Motion for Reconsideration of the Order, dated 12 November 2019 with Motion for Leave of Court to serve Summons by publication, the dismissal of the case was set aside and leave was granted to serve summons on defendant, by

The case was subsequently dismissed, upon plaintiff's noncompliance with the Order, dated 22 June 2022. The dismissal was set aside, with the plaintiff's filing of the Omnibus Motion With Sincerest Apologies.

Upon plaintiff's presentation of proof of compliance with the requirements of the service of summons by publication, and upon its motion, the defendant was declared in default and plaintiff was allowed to present its evidence.

The plaintiff presented its witnesses Michael Nolasco and Pepito C. Taas, Jr.

Michael Nolasco testified through his Judicial Affidavit, dated 13 October 2023 and in court.

He identified himself, as the marketing sales representative, and authorized representative of the plaintiff, for the purpose of the herein case, as shown by the Secretary's Certificate, dated 5 October 2017. He declared that the plaintiff is a corporation registered under the Securities and Exchange Commission, as shown by the corresponding Certificate of Incorporation, dated 19 September 2000 and Articles of Incorporation, dated 18 August 2000. He further declared that the defendant One Mega Builders Construction Corporation is a corporation registered under the Securities and Exchange Commission, as shown by the Certificate of Incorporation, dated 6 December 2010, and Articles of Incorporation, dated 28 October 2010.

The defendant through its owner/president Ma. Czarina Lagman, entered into Contract Proposals and Agreement Nos. 10542 and 10636 dated 17 March 2016 and 23 April 2016, respectively, for plaintiff to supply it with various quantities of ready mix concrete cements. Pursuant to the said contracts, plaintiff sold and delivered to the defendant, various quantities of ready mixed concrete cement, as shown by the following:

Nolasco subsequently identified the signatures of the defendant's representative Kim Orbase in the delivery receipts, sales invoices and billing statements. He also identified the signatures of plaintiff's employees/dispatchers Alvin Alvarez, Arnel Vilan and Tzaddi Valdellon, and defendant's employees Engr. J. Pacios, Aizalyn Ubaldo and Maurice Jade Paragos, on the delivery

Defendant thereafter failed to pay for cements it purchased, and plaintiffs counsel served it with the final demand letter, dated 21 February 2017, seeking the settlement of its obligations, which amounted to Php 947,560.90, as shown by the Statement of Account, as of 16 February 2017. Defendant refused to comply with the said demand, resulting in the filing of the hearing case.

Nolasco added that he dealt with the plaintiff's clients, once they give the purchase order, and he monitored the deliveries. In defendant's case, he dealt with its project manager on site and its purchasing manager Kim Orbase in the office. He accompanied the deliveries made and the Delivery Receipts were signed by the defendant's staff. The sales invoices were received at the Accounting Department of the defendant's office. The plaintiff's accounting head subsequently took custody of the signed delivery receipts and signed sales invoices.

On clarificatory questioning, Nolasco stated that the sales invoices are prepared, two to three days after each delivery.

The plaintiff's next witness Pepito C. Taas, Jr., testified through his Judicial Affidavit, and in court.

In his testimony, he identified himself as part of the accounting

staff of plaintiff's counsel Corpuz Ejercito Macasaet Rivera & Corpuz Law Offices, and he is familiar with plaintiff, since he has encountered its account while reviewing billing statements and monitoring payments, in the course of performance of his duties at said law office. He stated that pursuant to the Engagement Fee Agreement, dated 18 June 2009, the plaintiff has incurred costs and expenses for the legal services rendered by their law office pursuant to this case, as shown by the Statement of Account for the Unpaid Services, as of 11 March 2024, in the total amount of Php 8,565.00, in unpaid expenses and Statement of Account for the Paid Services, in the total amount of Php 32,923.50, as shown by Official Receipt No. 0010480.

The sole issue for resolution is whether the defendant is liable to pay plaintiff, the following: Nine Hundred Forty Seven Thousand Five Hundred Sixty Pesos and Ninety Centayos (Php 947.560.90), as the total outstanding obligation for the purchases, as of 16 February 2017; interest of 18% per annum on the amount, from 20 April 2016 until full payment; 25% of the total amount due, as attorney's fees, and appearance fee of Three Thousand Pesos (Php3,000.00), for every hearing attended by counsel. and: cost of suit.

The rights and obligations of the parties herein shall be determined by the contract/s that they executed between them. Jurisprudence has decreed, thus:

It is well-established that a contract is the law between the parties. Obligations arising from contracts have the force of law between the contracting parties and should be complied with in good faith. "Unless the stipulations in a contract are contrary to law, morals, good customs, public order, or public policy, the same are binding as between the parties." From the moment the contract is perfected, the parties are bound not only to the fulfillment of its stipulations, but also the consequences which, according to their nature, may be in keeping with good faith, usage, and law.

The parties executed Contract Proposal and Agreement Contract

Nos. 10542 and 10636, dated 17 March 2016 and 23 April 2016, respectively. Pursuant to the said agreement, the plaintiff undertook to supply all labor materials and equipment supervision, for the work described, in the said contracts, to the defendant.

Based on the Statement of Account, as of February 16, 2017, the defendant has outstanding obligations for nonpayment of the following: Php 615,600.00, under Sales Invoice No. 63320; Php 30,780.00, under Billing Statement No. 1575, and; Php16,250.00, under Sales Invoice No. 63372, or all in the total amount of Php662,630.00.

The proof of receipt of the items and service were shown by the signatures of employees of both plaintiff and defendant, on the corresponding Delivery Receipts, Sales Invoices and Billing Statement. Defendant's receipt of the demand letter, on 23 February 2017, was shown by the signature of its authorized representative Adrian Forfeida.

Hence, the plaintiff sufficiently established that it is entitled to the payment of the value of the goods and services delivered, in the total amount of Php 662,630.00. In Isla v. Estorga, the Supreme Court gave the following discussion on monetary interest and compensatory interest, thus Case law states that there are two (2) types of interest, namely, monetary interest and compensatory interest. Monetary interest is the compensation fixed by the parties for the use or forbearance of money. On the other hand, compensatory interest is that imposed by law or by the courts as penalty or indemnity for damages. Accordingly, the right to recover interest arises only either by virtue of a contract (monetary interest) or as damages for delay or failure to pay the principal loan on which the interest is demanded (compensatory interest).

In the herein case, the submitted copies of the contracts between the parties, failed to reflect the provision on the imposition of the monetary interest. However, said contracts were supplemented by Sales Invoices, containing the following common provision:

TERMS: All sales other than Cash or C.O.D. are understood to be payable upon presentation of invoice, and or not later than ten (10) days after date of invoice, unless otherwise agreed upon. Interest of 12% per annum is to be charged on all overdue accounts. An additional sum equal to 25% of the amount will be charged by the Vendor for Attorney's fees and cost of collection in case of suit."

The Billing Statement, on the other hand, contained the following common provision, thus: Interest annum is to be charged on all accounts overdue plus 25% of said amount for Attorney's fees and cost of collection in case of suit. xxx

Under the Sales Invoices and Billing Statements, an interest of 12 % per annum shall thus, be charged on all overdue accounts and it is considered the monetary interest for which defendant is liable, in contemplation of the abovecited jurisprudence.

As previously discussed, the grant of compensatory interest is also mandated by law, thus:

In addition, not only the principal amount but also the monetary interest due to respondent as discussed above shall itself earn compensatory interest at the legal rate, pursuant to Article 2212 of the Civil Code, which states that "[i]nterest due shall earn legal interest from the time it is judicially demanded, although the obligation may be silent upon this point." To be sure, Article 2212 contemplates the presence of stipulated or conventional interest, i.e., monetary interest, which has accrued when demand was judicially made. In cases where no monetary interest had been stipulated by the parties, no accrued monetary interest could further earn compensatory interest upon judicial demand. Thus, the principal amount and monetary interest due to respondent shall earn compensatory interest of twelve percent (12%) per annum from judicial demand, i.e., the date of the filing of the complaint on July 24, 2007, to June 30, 2013, and thereafter, at the rate of six

percent (6%) per annum from July 1, 2013 until fully paid. Hence, plaintiff is entitled to compensatory interest of 6 % per annum, from the judicial demand or from the filing of the complaint in court, on 28 February 2018.

It appearing that the under the abovequoted provisions of the Sales Invoice and Billing Statements, attorney's fees and costs of suit equivalent to 25 % of the unpaid amount shall be paid, then defendant is additionally liable for such fees, pursuant to Article 2208 of the Civil Code.

Wherefore, premises considered, Judgment is hereby rendered GRANTING the Complaint, and defendant One Mega Builders Construction Corporation is ORDERED to pay plaintiff Phoenix Ready Mix Concrete Development & Construction, Inc.,

(a) Six Hundred Sixty-Two Thousand Six Hundred Thirty Pesos (Php 662,630.00), representing the unpaid obligation; (b) Monetary interest at the rate of twelve percent (12%) per annum, from the date of extraiudicial demand made on 23 February 2017, until fully paid;

(c) Compensatory interest on the monetary interest as stated in letter (b) at the rate of six percent (6%) per annum from judicial demand or the date of filing of this Complaint, on 28 February 2018, until fully paid; and

(d) Legal interest at the rate of six percent (6%) per annum imposed on the sums due in letters (a), (b), and (c) from finality of this Judgment, until full payment.

Let this Judgment be published twice, for two (2) consecutive weeks, in a newspaper of general circulation, as may be chosen by raffle, pursuant to Rule 13, Section 13 of the Rules of Court.

New DILG chief to shut down POGOs 'one by one'

Department of the Interior and Local Government (DILG) Secretary Jonvic Remulla on Wednesday vowed to shut down all Philippine Offshore Gaming Operator (POGO) hubs in the country.

"As far as I am concerned, I will get all the list of POGOs and I will personally lock them down, one by one, personally, lahat sila (all of them)," Remulla said after assuming his new post as DILG chief in turnover rites in Quezon City.

He said he has already talked to the officials of the POGO hub operating in Island Cove in Kawit, Cavite, a resort property previously owned by his family.

"They will close down Dec. 15 for good," he added. Remulla,

meanwhile, said all officials of the DILG would remain in their posts

"The instructions of President (Ferdinand R.) Marcos (Jr.) are very clear. One is the recommended said they are looking at areas

structural reforms for the various agencies under the DILG. Next is the increased responsiveness of the local governments (and) last is the safety and security of the candidates and the public for the 2025 elections," he said.

Remulla said he wants to ensure "zero casualty" for next year's midterm elec-

The former Cavite governor recalled some measures he implemented to ensure peace and order in past elections in Cavite.

"What I did was each and every candidate for mayor (was) always accompanied by (a) mobile patrol vehicle," he said, clarifying that the police officers did not serve as bodyguards of these candidates. "Maybe we can do (the) same but I don't know if mobility is possible. But we will enlist the help of all agencies of government to make the elections as peaceful as possible."

At least 16 people died during the entire election period in the 2022 elections.

Remulla, meanwhile,

in the Bangsamoro Autonomous Region in Muslim Mindanao, Cagayan, Nueva Ecija, and Palawan as hotspots for next year's midterm polls.

"Those are premature, just off-the-cuff assessments. We will get into a definite list in the next few weeks because filing (of certificates of candidacy or COCs) ended just yesterday (Tuesday). We will give a definite list afterwards," he said.

In a separate press briefing held in Camp Crame, Philippine National Police (PNP) spokesperson Brig. Gen. Jean Fajardo said the filing of COCs was generally peaceful, except for a shooting incident in Shariff Aguak town in Maguindanao del Sur on Tuesday.

The incident, between supporters of mayoral candidates, led to the death of one person and wounding of five others, Fajardo said.

The PNP is conducting a thorough investigation of the incident, which occurred near the town hall, she said, adding that police personnel who rushed to the scene were

also fired upon. Fortunately, no one was reported hurt on the side of the police.

"Hindi pa ito considered ERIs (election-related incidents) kasi wala pa tayo sa (because we are not yet in the) election period. The directive of our Chief PNP, Gen. Marbil, is to intensify police presence and border controls, as well as the conduct of strategic checkpoints, particularly those in areas where there are potential ERIs to prevent a repeat of these incidents, as well as possible violence," Fajardo

"We also remind all our personnel to remain non-partisan in strict adherence to our constitutional mandate," PA spokesperson Col. Louie Dema-ala said in a statement. PH Marines, counterparts from 5 nations to join 'KAMANDAG' drills

Elite troops of the Philippine Marine Corps (PMC) and their counterparts from the United States, Japan, South Korea, the United Kingdom, and Australia will participate in this year's "KAMANDAG 08-24" exercises on Oct. 15-25.

In an advisory on Friday, the PMC said it would join the US Marine Corps (USMC) as primary participants in the drills, which stands for "Kaagapay ng Mga Mandirigma ng Dagat."

They will be joined by forces from the Japan Ground Self-Defense Force, Republic of Korea

Marine Corps, United Kingdom Royal Marine Commandos, and Australian Defense Force. Some 2,351 personnel are taking part in the exercise, it added.

The Philippines will be deploying 150 personnel coming from the PMC, Marine reservists, Philippine National Police and the Philippine Coast Guard.

Meanwhile, the USMC will be deploying 1,072 personnel; South Korea, 58; Japan, 54; United Kingdom, eight; Australia, five; France, two; Thailand, one; and Indonesia, one.

The "KAMANDAG" drills are part of this year's activities set by the Mutual Defense Board - Security Exchange Board, composed of Philippine and US security officials.

"The main exercise venues will be conducted across various training areas within the Northern Luzon Command, Western Command Joint Operational Areas, as well as in Manila and Cavite," the PMC added.

It has yet to determine the exact number of participating troops to date.

LTO suspends 3 more driving schools for fraudulent certificates

The Land Transportation Office (LTO) on Monday suspended three more driving schools in Metro Manila and Cavite for alleged fraudulent issuance of theoretical (TDC) and practical driving course (PDC) certificates.

In a statement, LTO chief Assistant Secretary Vigor Mendoza II said a



driving school in Las Piñas City, another in Caloocan City, and one in Silang, Cavite have been issued 30-day suspensions based on intelligence reports that they issued certificates despite non-completion of the courses. Both TDCs and PDCs are major requirements in the application for a driver's license. "May nakumpirma tayong impormasyon sa maling gawain ng mga driving schools (We have confirmed fraudulent activities by these driving schools). They are now the subject of the investigation and part of the due process is to issue them with a show cause order (SCO)," Mendoza said. An initial report showed the driving schools were issuing PDC and TDC certificates despite non-completion of required hours and seminars for their students in exchange for payment. "This illegal practice is dangerous. It must be stopped since those who were issued with fraudulent driver's licenses would most likely endanger the lives of road users for lack of proper training and education," he said. In the SCO signed by LTO Central Accreditation Committee on Driving Institutions chair Greg Pua, the driving schools were asked to explain in writing why they should not be punished based on existing LTO rules, particularly the LTO Memorandum Circular No. VDM-2023-2460, or the Revised Omnibus Guidelines on the Accreditation, Supervision, and Control of Driving Institutions, and Standardization of Driver and Conductor's Education. On Sunday, Mendoza also ordered a 30-day suspension against two driving schools in Lucena City and San Sebastian, Tarlac for similar offenses. (PNA)
