BOC destroys P34-M forfeited vape products in Cavite

Close to 160,000 forfeited vape products worth over PHP34 million were recently condemned in Cavite, the Bureau of Customs (BOC) reported on Friday.

A total of 159,830 pieces of vape products valued at PHP34,112,500 went down the drain at a private facility in the province on Jan. 17 and 20, according to a news release Friday.

"This condemnation underscores commitment to protect public health and ensure compliance with our laws," Customs Commissioner Bienvenido Rubio said in a

in the second quarter. He said commuters can expect to cut their travel time by at least half when using the transport system that is designed with dedicated bus lanes. He also said the BRT would have scheduled trips, allowing commuters to better estimate their travel time.

Initially, Saavedra said they were projecting about 10,000 daily ridership. But this could go as high as 50,000 when all the stations of the BRT are operational, he added.

Megawide received the notice of award from the local government of Cavite on Jan. 8. The company is working with local investment holdings company Maplecrest Group Inc. for this project.

The BRT project will span 42 kilometers across the cities and municipalities of Cavite—particularly Imus, General Trias, Tanza, Kawit and Trece Martires—and surrounding areas to provide a link to Meto Manila.

According to the terms of the project, the project will include 37 stations and three terminals.

The chosen private concessionaires, who are tasked with financing and constructing the project, are granted a 30-year concession period. The assets will be turned over to the government after.

It will be connected to the Parañaque Integrated Terminal Exchange, giving commuters a point-to-point link between Cavite and Metro Manila.

NACC Celebrates 3rd Year, Aims for More Forever Families

PARAÑAQUE CITY – The National Authority for Child Care (NACC), the country's central authority on administrative adoption and alternative child care renewed its commitment to its mission and advocacy during its third anniversary celebration at Parañaque City, Monday,

In 2022, the 18th Congress enacted R.A. 11642 or the Domestic Administrative Adoption and Alternative Child Care Act creating the NACC as a one-stop quasi-judicial agency under the Department of Social Welfare and Development (DSWD) to formulate policies and implement programs and services on administrative adoption and alternative child care.

R.A. 11642 further streamlined all government programs and services on the declaration of a Child Legally Available for Adoption, Domestic Adoption, Inter-Country Adoption, and other forms of alternative child care such as foster care, kinship care, and residential care.

"As we celebrate the NACC's third year anniversary, it is my hope and prayer that we renew our commitment to our shared mission of placing every child and individuals in need of adoption and alternative care with suitable, secure, nurturing and their forever families," said NACC Undersecretary Janella Ejercito Estrada in a statement.

"True to our mantra that every child matters, let this be our reminder to reach every child and every family, wherever they are, as hard as it can be, or as impossible it may seem. No child should be left behind," emphasized Usec. Estrada.

"Since the NACC's establishment of NACC in 2022, we continue to build our institutional capacity – evident in the 16 Regional Alternative Child Care Offices (RAC-COs) now accessible to all of our kababayans responding to their concerns," said Usec. Estrada.

Since 2022, the NACC reported that it was able to place a total of 968 children for domestic administrative adoption and inter-country adoption - with issued Decrees of Adoption of 629 and 154, respectively. From 2023 to 2024, 1,069 children were declared legally available for adoption.

DA in talks with more LGUs for nationwide NFA rice sale

FEBRUARY 2-8, 2025

The Department of Agriculture (DA) is coordinating with select local government units (LGUs) for the sale of National Food Authority (NFA) rice nationwide.

The sale of NFA rice to LGUs, government agencies and government-owned-and-controlled corporations worth PHP36/kg., including newly milled or not yet aging rice, is allowed under a food security emergency for rice that has yet to be declared.

"Basically, nationwide ito pero kung saan malapit 'yung stocks... Mangyayari diyan is iyong guidelines na labas namin (This will be nationwide but for those near the stocks... What will happen is that we will release the guidelines) by the end of the month. So it will take time for them to really look at it," Agriculture Secretary Francisco Tiu Laurel Jr. said in a

dinner interview late Thurs-

He said the initial move aims to reduce freight or logistics costs and maintain the affordable level of NFA rice for consumers.

"We cannot give all municipalities or LGUs or cities. Ang diskarte (The strategy) for minimal friction cost is kung ano pinakamalapit sa stocks, iyon ang bibigyan ng mga (wherever is nearest to the stocks, that will be given the) allocation," Tiu Laurel said.

Under the food security emergency for rice, the DA can sell NFA rice to LGUs and other government bodies starting Feb. 1, which can then be sold to consumers at PHP38/kg.

"They can book already. Then maybe the delivery is maybe February 7 to 15," Tiu Laurel said, citing the transmittal of letters from the NFA to select LGUs to identify their intent and vol-

ume allocation needed. The DA earlier met with Metro Manila mayors to ensure the availability of NFA rice in the region.

For the initial monthly target, at least 9,000 bags of NFA rice will be allocated for the 17 cities and municipalities in the National Capital Region; and 3,000 bags in Calamba, Laguna.

Other areas with high NFA stocks include Calapan City in Oriental Mindoro and San Jose in Occidental Mindoro

"It will be foolish for us to mill it and send it to Luzon or Mindanao for additional freight costs. So, kung kaya lang ma-consume iyon within Mindoro, then subukan ubusin iyon (If they can consume it within Mindoro, then they can try to exhaust it)," Tiu Laurel said.

He also said Mindoro can also supply NFA rice to Cebu.

To date, almost 300,000

metric tons (MT) of NFA rice stocks may be sold under a food security emergency for rice. The DA, however, is yet to receive the official copy of the resolution from the National Price Coordinating Council for the declaration. "The draft has been given and they're finalizing or have finalized already and I'm actually assuming that it is already going around for signature," Tiu Laurel said.

Besides making cheaper NFA rice available to the public, the said declaration will also enable NFA to free up warehouse spaces and support local farmers through palay (unhusked rice) procurement for the upcoming harvest season. (PNA)

Several companies from the United States have expressed interest in the Philippines' semiconductor and electronics global chain value, the Philippine Economic Zone Authority (PEZA) said on Saturday.

In a news release, the PEZA said the Philippines secured new leads following its participation in the Consumer Electronics Show (CES) 2025 held Jan. 8 to 11 in Las Vegas, Nevada.

"I am upbeat with the reception from the US Companies and the possibility that they may invest in the Philippines in the near future," PEZA Director General Tereso Panga said.

"Some talks have already started, jumping off from the initial engagement, to realize these potential investments in the coming months," he added.

Aiming to build new connections, the PEZA met with various US-based firms, including Quintel Solutions, a subsidiary of long-standing PEZA locator Cirtek. Quintel is considered the global market leader for multiport antennas, serving leading Telecom carriers in North America.

The PEZA also met with the top officials of ON Semiconductor Corporation (Onsemi), a leading semiconductor manufacturer with over 80,000 different parts, including advanced MOSFETs (metal-oxide-semiconductor field-effect transistor), image sensors, silicon carbide technology (EliteSiC) and a global supply chain.
