

liable. "We in the LTO Mendoza cannot enforce road safety alone, especially outside Metro Manila. We need the LGUs (local government units) like the city government of Carmona, it has been doing very well in assisting the national government in its goal of making the roads safe for everybody,"

Erring said. motorists who escape traffic enforcers, he said, could later be identified if their license plate is obtained.

"The LGU of Carmona City could send us the information and in return, the LTO could issue a show cause order to the registered owners of vehicles that violated traffic rules and regulations," he said. The agreement, he added, is part of the advocacy of Transportation Secretary Jaime Bautista for road users' safety and the LTO's newly-launched "Stop Road Crash" program.

in Kawit, Cavite. The closure of the 33-hectare facility, the largest POGO hub in the country, is in compliance with President Ferdinand "Bongbong" Marcos Jr.'s directive to cease all POGO operations in the Philippines.

Covelandia, once a sprawling resort island, began operations as a POGO hub in 2018 after securing its permit from PAGCOR in 2003. It housed 58 buildings and employed around 30,000 personnel, with 50% of its workforce being Chinese nationals. "The directive to shut down POGO operations reflects the government's commitment to maintaining public order and addressing concerns associated with the industry," said Secretary Remulla during the event.

Chairman Tengco echoed this sentiment, emphasizing PAGCOR's commitment to upholding the President's policy. "This

closure is a significant step toward ensuring that our regulatory measures align with the best interests of the country," he stated.

General Marbil and Brigadier General Lucas assured the public of the PNP's readiness to enforce the closure orders and address any related security concerns.

The move to shut down POGO hubs comes amid growing concerns

illegal activities, including human trafficking and money laundering, linked to the industry. The government is determined to repurpose facilities like Covelandia to benefit local communities and the national economy.

PAOCC Chait Usec Gilbert Cruz said that, together with the PNP, they will start their crackdown of the operation of all smalltime POGO hubs in the country.

The Provincial Housing Development and Management Office (PHDMO) successfully hosted the Presentation and Discussion of Local Shelter Plan - Provincial Level on December 18, 2024, at the Ceremonial Hall of the old Provincial Capitol Building in Trece Martires City.
