about the health and nutritional benefits of breastmilk. These gatherings aim to create visible community support for breastfeeding and to remind the public that breastfeeding is the best start for infants.

The activity featured a lecture on breastfeeding by Dr. Jindra Tetangco of the Philippine Pediatric Society -Southern Tagalog Chapter. She delivered an informative and encouraging lecture covering breastfeeding techniques, proper latch, common concerns (sore nipples, low milk supply), and how family members can support a breastfeeding mother. Participating mothers took part in demonstrations and had the opportunity for one-on-

one consultations with health staff. The event emphasized both the science and the everyday realities of breastfeeding, helping mothers gain confidence and practical skills.

To close the program, Dr. Laura Maria Soledad A. Aguinaldo, GEAMH Breastfeeding Coordinator, delivered an inspiring message, commending the mothers for their commitment to

giving their children the best start in life and encouraging them to continue breastfeeding with the support of their families and community.

She also encouraged attendees to continue accessing local maternal and child health services and to join peersupport activities to sustain breastfeeding beyond the hospital stay. --- JDP

According to DPWH, the multi-package project has reached varying completion rates, with the San Juan Diversion Channel at 27.21%, Rio Grande River Improvement at 22.60%, Ylang-Ylang River

Improvement at 33.89%, and Maalimango Creek and Drainage works at 54.98%. A resettlement program under CP-5 is nearly finished at 95.81%, providing 887 housing units for affected families.

Funded through a P22-billion JICA loan, the entire project is slated for completion in 2029. Officials noted that early flood mitigation measures—such as retarding basins built in General Trias and Imus—

have already reduced flooding during recent typhoons and monsoon rains.

Mayor Chua praised the use of high-grade materials and modern technology in the project, crediting DPWH and JICA for substantial progress in Cavite's flood resilience. (Source: Journal Online)

PGC's Medical and Dental Mission Serves Tanza Residents

TANZA, Cavite — The Provincial Government of Cavite (PGC) extended free healthcare services to residents of Springtown Phase 1 Main Subdivision, Barangay Bucal, through a medical and dental mission aimed at strengthening access to essential health services.



A total of 668 patients

benefited from free medical consultations, while 90 individuals availed of dental care services. The mission also provided 31 X-ray examinations and 18 ECG tests, alongside the distribution of free prescribed medicines and vitamins to support patient recovery and wellness.

The activity was attended by Tanza Councilors Ryan Mintu and Derek Matro, as well as 7th District Board Member Aldrin Anacan, who expressed their support for the initiative. US Donates Equipment for PCG Fleet Maintenance By Marita Moaje, PNA

The United States has donated PHP1.9 million (USD34,500) worth of equipment to the Philippine Coast Guard's (PCG) Fleet Maintenance and Repair Group (MRG) Workshop in Sangley Point, Cavite, reaffirming its commitment to strengthen Philippine maritime security.

The donation, turned over on Aug. 18 through the US Department of State's Bureau of International Narcotics and Law Enforcement Affairs (INL), is expected to enhance the PCG's capacity to maintain and repair its vessels.

"This activity is another important step in our capability buildup to provide the necessary equipment for our MRG," said PCG Fleet Commander Rear Admiral Rommel

Bohol Explores Tourism Links with Subic-Clark

The Provincial Government of Bohol held a productive discussion with local tourism stakeholders, highlighted by the visit of Atty. Amee Fabros, Executive Director of the Subic-Clark Alliance. The meeting, held last August 5, explored prospects for a vibrant partnership in trade and investments, with a strong focus on boosting tourism through closer collaboration with the Subic-Clark corridor. Inspired by the insights shared by Atty. Fabros, who noted that Bohol offers many exceptional tourist attractions not found in Central Luzon, said the Province is eager to pursue collaborative efforts to promote regional tourism. Boholanos have also shown growing interest in exploring Central Luzon and Northern Luzon destinations such as Subic, Clark, Baguio, Nueva Ecija, Tarlac, Bataan, and Pagudpud, Ilocos Norte. This engagement provides an opportunity to further promote Bohol's unique tourist destinations, particularly its distinction as a UNESCO Global Geopark.

Supangan, adding that the assistance underscores strong US-Philippine maritime cooperation.

INL Director Kate Richie said the support will allow the PCG to sustain its fleet more effectively. "This transfer of essential equipment and backup power supply will enable a broader and more effective repair program," she noted.

The Sangley Point facility, inaugurated in May 2024 with PHP54 million (USD950,000) in US funding and Coast Guard technical support, complements an existing MRG workshop in the Manila Port Area. Both aim to strengthen maintenance capability for small boats and large patrol vessels vital to law enforcement and maritime defense.

INL and other US agencies are also preparing further assistance, including technical training, logistics planning, and additional equipment donations for PCG operations.
