You are invited to join SMU Associate Head Coach, Cristine Dixon and her coaching staff for 2 days of training with other players from Colleyville Heritage High School. This is a great opportunity to receive outstanding volleyball instruction and prepare for the start of the 2019 season.

Cristine Dixon is in her 20th season (2019) on the Hilltop, and her 14th as the top assistant coach under head coach Lisa Seifert. In the summer of 2011, she was promoted to Associate Head Coach. Dixon has coached 37 All-Conference Players, 67 Academic All-Conference Honorees, 14 players nationally-ranked in individual categories, and Eight All-America Honorable Mentions. Dixon is a graduate of Texas Tech University. Dixon, who was named to the Texas Tech All-Millennium Team in 1999, started at Tech each of her four years (1994-97) and is still ranked in several school records, including service aces, digs and kills.

She will be joined by Courtney Ries. Courtney is a graduate of Texas Tech where she played defensive specialist. She is a member of the Texas Tech Volleyball All Millennium Team honoring the top all-around student-athletes in the program's history. Ries currently coaches at Skyline Juniors. Coach Dixon will be joined by other members of the SMU staff as well.
