CONSIGNMENT AGREEMENT

PRICING:

- We base prices on resale value and current demand. We will try to get the best price for you. Please be aware that pricing is discretionary and subject to additional store sales and specials throughout the selling period.
- We authenticate all luxury items through a 3rd party. If we are unable to authenticate your item there will be a \$25 service charge.
- If you have concerns about how a particular item will be priced, please let a staff member know during the intake process.

COMMISSION AND PAYOUTS:

- You will receive 40% of the final selling price on regular merchandise.
- Luxury bags will receive 50% and luxury shoes/accessories will receive 40% excluding sales tax/fees.
- Balances may be paid of any amount by Venmo monthly. Payout by check is also available and may be requested. Checks are issued after the first month and after the first of the month for each consecutive month. You may call or come into the store for a check pick up in the shop.
- The selling period for your items lasts 60 days from drop-off. You may retrieve any unsold items by the assigned pick-up date. Please call to make arrangements for pick up for any unsold items. In the event of early termination and you choose to pick up items within the 60 day selling period, the consignor agrees to pay Boutique on the Buy Way a 5% stocking fee based on the listed price of the item. Fee is due upon pick up.

Future Plans:

The Boutique may start online sales in the near future. If an item sells online the shipping fee will be the responsibility of the consignor.

Consignor Guidelines

Select your IN-Season clothing, shoes, and accessories. Please make sure everything is in excellent, like-new condition and is freshly cleaned, pressed, and folded neatly. They may be on hangers and staff will replace them with the boutique's own hangers. Hangers will be disposed of or returned at intake. There will be a steaming, de-pilling, hair removal fee of 3.00 per item if they are in need of those processes, to be paid at intake.

1. Clothes sell only in-style and on-trend. We choose based on the styles our customers are currently buying and accept all designers but are more particular with fast-fashion brands. We recommend items have been purchased within the previous 3 years. Only High-end couture vintage items at the discretion of staff.
2. You can call for an appointment to bring 20 items or less. appointments will be Wednesday or Thursdays between 11AM - 4PM during winter hours. More appointments will become available when new hours are posted.
3. The Boutique sets the selling price. When an item sells, you receive 40% of the selling price (50% for luxury bags and 40% for luxury accessories/shoes...see some of the luxury designers we offer this split for below).
4. If we find any previously undetected defects, you will be notified to retrieve the items or you can choose to donate them.
