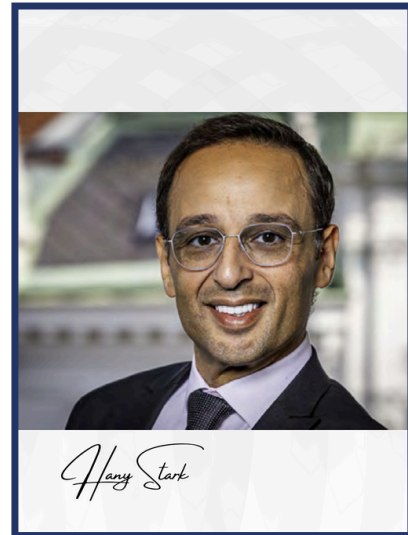
## Founder's Message,

#### Dubai International Airport

Luxury defines Dubai, and its DXB International Airport has recently won many awards. It is primarily an international airport that provides flights worldwide; passengers have always loved it and rated it as a classy experience.

Location: In the Al Garhoud district, 4.6km to the east of Dubai

#### Abu Dhabi International Airport

The second largest airport in the United Arab Emirates opened on January 2, 1982, as part of a plan to modernize the country. The airport, which has three terminals, is wholly owned by the government of Abu Dhabi.

Location: 38km to the southeast of the center of Abu Dhabi

#### Sharjah International Airport

It ranks third in the list of airports in the United Arab Emirates by size. It has eight departure gates and 25 aircraft stations. Air Arabia, Etihad Airways, Saudi Airlines, and Egypt Air are the few airlines operating here since its establishment in 1977.

Location: 15km from Sharjah city center.

#### Al Maktoum International Airport

Al Maktoum International Airport, also known as Dubai World Central, is Jebel Ali International Airport, 37km southwest of Dubai and 40km from Dubai International Airport. It can handle over 12 million tons of cargo per year and 160 million passengers per year and can handle all new-generation aircraft, such as the superjumbo A380.

The airport is potentially the most significant global airport, but more is needed. Some charter airlines fly from Europe to Al Maktoum International Airport, but only a few are scheduled flights. The latest information says that completion is postponed until 2030.

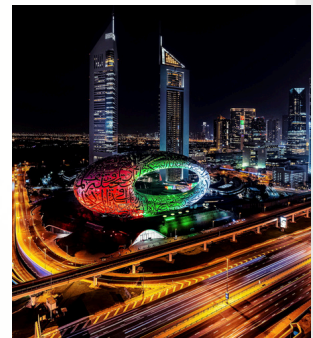
