But recent rain aside, we're all worried about Canyon Lake's long-term future. I've spent the past six months working to bring awareness to the drought's impact on our community and properties. Continue reading for a summary and to understand why this situation demands our immediate action.

When you can, I urge every Enclave property owner to contact our elected officials about how our lake is being managed. They are listening, and if enough of us reach out, we might get real answers and changes.

# **WATER WOES**

Dear Neighbors,

Back in November, I made a commitment to you that I'd do everything in my power to increase awareness about our growing water shortage through political channels. I want to update you on what I've learned—and more importantly, what we need to do next.

Over the past several months, I've been knocking on doors (metaphorically speaking) from Austin to Washington. I've reached out to Congressman Chip Roy's staff, met with him on April 29th, had dinner conversations with Senator Ted Cruz, and even bumped into Governor Abbott on April 30th. The good news: they're all aware of—and concerned about—our situation. The sobering news: awareness won't fill Canyon Lake.



At the recent library meeting with Commissioner Jen Crownover and our local water board, officials confirmed that this drought is the worst on record we've ever experienced. The water evaporation rate is exceeding the fill rate in Canyon Lake, and we're looking at Stage 4 water restrictions potentially lasting several years—yes, even through winter months. Weather cycles will eventually change for the better, but changed isn't projected anytime soon.

While there's a common misconception that Canyon Lake is still taking on new projects, they have stopped selling water to new communities (though they must honor existing contracts).

As we drive around the area, we all see the stark reality of drought's impact on local businesses. This isn't just about inconvenient watering schedules or brown lawns—this is about our community's economic survival and impact to property values.

Officials are exploring solutions like converting wastewater to fresh water, but that requires millions of dollars and years of infrastructure development. Desalination from seawater? Expensive and unlikely for our inland location.

# **WATER WOES**

I've invited Congressman Roy out during his next congressional break so he can see our situation firsthand. In the meantime, **I'm asking for your help** to demonstrate that this community is unified and engaged on this issue.

It's time to make waves about our water crisis. Here's our collective mission and my challenge to you:

- Call (don't write) the offices of Chip Roy, Ted Cruz, Donna Campbell, and Greg Abbott (see Page 1 for phone numbers) and express your concerns about our regional water crisis
- Contact County Commissioner Jen Crownover to show community support for water infrastructure investments
- Reach out to your state representatives about funding for drought mitigation projects
- Ask about mitigation for our current situation—are there state funds for low-water landscape conversion or to offset impact to our property values?
- Ask them to prioritize legislation and protections for when our lake is full again. What can they do to ensure water won't be oversold to new projects?

Remember, Canyon Lake was never designed as a recreational lake with guaranteed water levels—it's an overflow reservoir. But that doesn't mean we should accept watching our community dry up without a fight.

We can't make it rain, but together we might make enough noise to ensure our elected officials prioritize solutions that prioritize our lake community.

Your voice matters and your calls count! Stay engaged, stay hopeful, and stay hydrated!

We are currently under Stage 4 watering restrictions. Nearly all outdoor water use is prohibited. This includes washing of impervious surfaces, filling swimming pools and water features, and lawn watering.







# FLOWER POWER: ANACACHO ORCHID TREE

Looking for a Texas native that thrives in heat and dry conditions? Check out the Anacacho orchid tree! Native only to a few canyons in western central Texas and in northeastern Mexico, Anacacho orchid is a 6-12 ft., single- or multitrunked shrub or small tree with small. light green, deeply cleft leaves. Anacacho orchid tree makes a gorgeous display with its silvery-gray bark and fragrant white flowers. The nectar attracts butterflies and bees.


