## Minutes for October 11, 2023 CCL-KC General Membership Meeting

1. The October 11, 2023 CCL-KC General Membership Meeting convened at the Plaza Library at 6:30 PM. Attending in person were Stephen Melton, Lorraine Elmore, and Frank Zilm. Attending via Zoom were Kurt Kloster, Karen Uhlenhuth, Paula Leppert, and newcomer Claudia Wilson, who is a freshman at St. Theresa's Academy in KCMO. Thanks to all who contributed to this meeting.

## 2. Announcements.

- a. The Energy Innovation and Carbon Dividend Act (H.R.5744) has been reintroduced. CCL priority now is to get House co-sponsors. Learn more at citizensclimatelobby.org. Click on the Take Action link.
  - b. CCL other emphasis now is bipartisan permitting reform legislation.
- c. Congress is focussed House Speaker election, international crises, annual spending bills, and the renewal of the five-year Farm Bill. May be a government shutdown or short-term continuing resolutions.
- d. CCL has scheduled a virtual conference, followed by lobbying, for the first weekend in November. This is a great opportunity to learn about CCL's strategy for the 118th Congress. - 3. Update on Energy Efficient Buildings.
  - a. IECC2021 is in full effect in KCMO and the phasing-in period is over.
- b. Frank reported that he and other members of the KC chapter of the American Institute of Architects are meeting with council members Bough and Bunch to maintain their support for the building codes. (There was some discussion regarding the greater receptiveness of the newly elected city council to climate action.)
- c. Parkville again discussed IECC2021 on July 18. No decision or vote. (No change since last month.)
- 4. Discussion on Urban Reforestation Next Steps.
- a. The group decided to write a letter to the KCMO council members and mayor, with the aim to strengthen the 2023 Tree Preservation Ordinance when it comes up for review early in 2024. Karen submitted a draft letter earlier in the day, which was briefly reviewed and lengthily discussed.
- b. An ad hoc committee consisting of Frank, Lorraine, Paula, and I volunteered to review the letter and provide comment back to Karen, who would produce a subsequent draft. If you wish to join the ad hoc committee and/or receive a copy of the draft, please contact me.
  - c. Our goal is to approve a final draft letter for my signature at our next meeting.
- d. Karen also regaled us with stories of her recent tree planting on city land and rights of way—46 trees in the last few days—and the infectious enthusiasm she and others have developed for the effort. ("Best thing I've ever done!"). We all agreed that we should continue to push this CCL priority.

## 5. Grassroots Engagement

Compost Collective KC processes over a million pounds of food waste yearly, diverting it from landfills where it produces methane, a gas that is 28 times more damaging than CO2. By composting organic waste instead of dumping it in a landfill, CO2 is reduced by 50%. Compost acts as a carbon sink, soaking up emissions currently in the air.

Please support these businesses in continuing their important environmental work."
