
WP FRAMEWORK FOR STRUCTURE OF RMs







Reducing the financial risk of holding conferences. Money, time, quality triangle. Events administrator.







Detailed up to date list of jobs available and human capital available. monthly basis/ yearly basis etc and time required to complete them.


