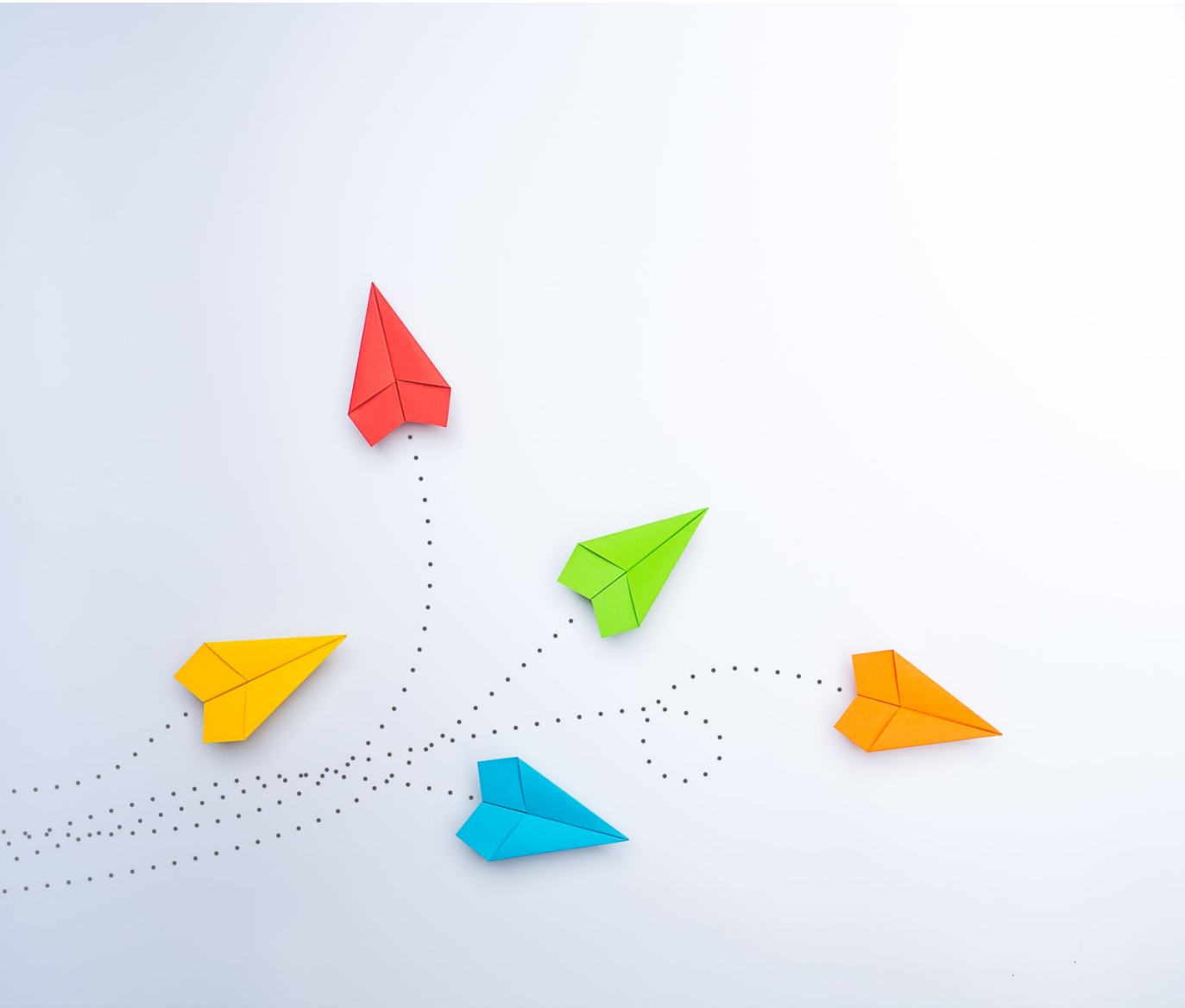

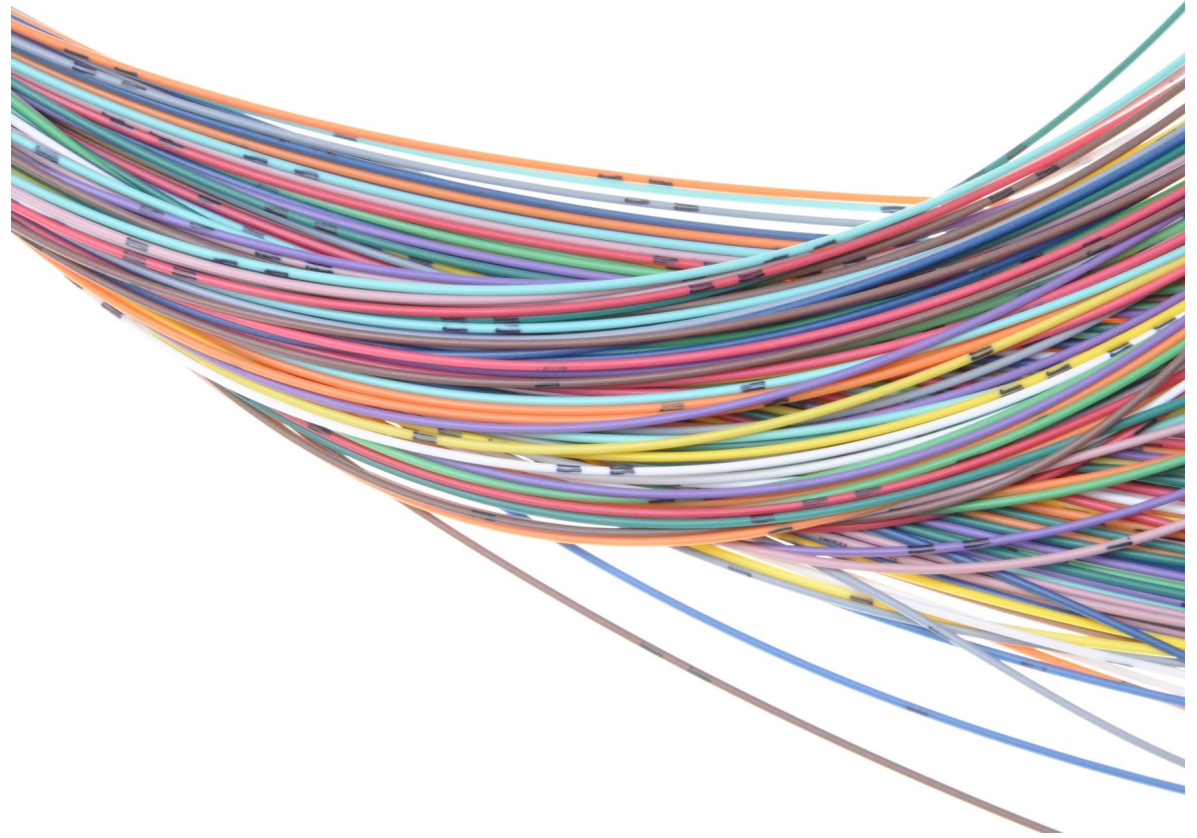

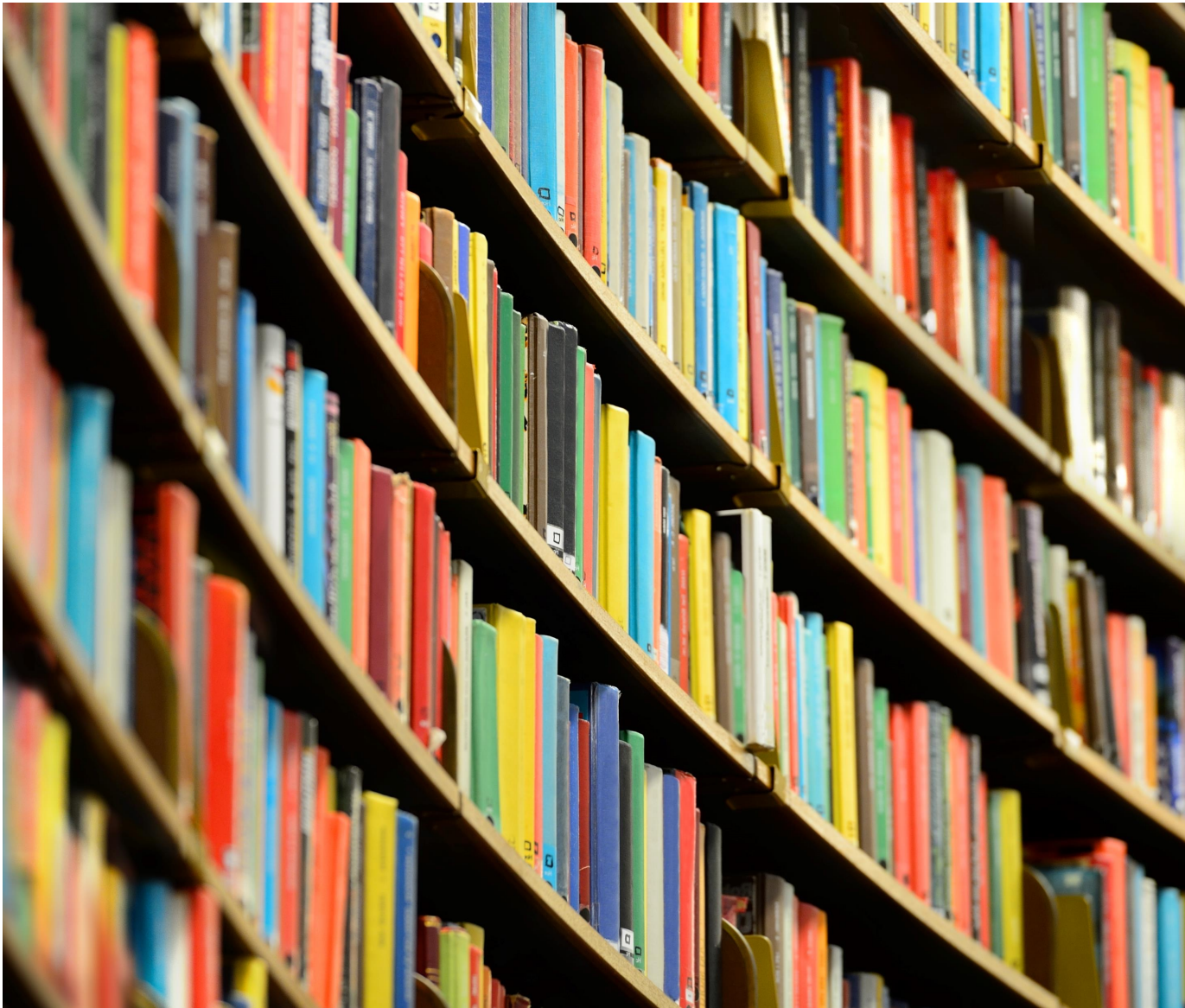
We want to hear from you! The data we have is helpful- but you can help us to better understand the results.
