WELCOME TO THE GLO PREEMIES NICU CITY "3 STEP PROGRAM". WE ARE EXCITED TO SUPPORT YOUR HIGH-RISK PREGNANT AND NICU FAMILIES. GLO PREEMIES IS A 501C3 AND WAS FOUNDED IN 2014 BY PRESIDENT ASHLEY RANDOLPH WHO IS ALSO A MOTHER OF 3 CHILDREN BORN PREMATURE, IT HAS ALWAYS BEEN A DREAM FOR ASHLEY TO OFFER A SUPPORT PROGRAM THAT PROVIDED FAMILY CENTERED CARE TO AFRICAN-AMERICAN NICU FAMILIES. ALL OF OUR IN-HOUSE SERVICES ARE FREE OF CHARGE TO OUR FAMILIES NATIONWIDE AND OVER 90% OF OUR SERVICES AND WORKSHOPS ARE VIRTUAL. FAMILIES WILL HAVE A CASE MANAGER WHO WILL BE THE "GO-TO" PERSON FOR ANY ASSISTANCE YOU MAY NEED.

What is the 3 Step Program?

Through a collaboration of over 70 organizations, healthcare insurance companies and companies nationwide

Step 1

The First Step is High-Risk Pregnancy

and includes Sign-up for NICU CITY "3 Step Program", workshops, doulas, transportation assistance, mental health therapy, and more.

Care boxes will be delivered directly to the families home after leaving the NICU until child turns 1 Years Old.

Hospitals have the option to have care boxes mailed to them quarterly to give to their NICU patients.

Step 2

The Second Step is from NICU Discharge until 5 years old and includes Sign-up for all available workshops, care boxes, transportation assistance, virtual home visitation, financial support, career support and more.

Step 3

The Third Step is from 5 Years old until 18 Years old and includes tutoring services, workshops, IEP review, transportation assistance, career workshop and more.

Who Can Sign UP?

African-American Families who are high-risk pregnant and/or has a child in the NICU can register.

Families who have been discharged from the NICU can still sign up for the program until the child reaches 18 years old.

Registration is open on a rolling basis on the website for families who are not being registered by a healthcare professional.

Healthcare professionals who sign up families will be automatically accepted for the program.

Healthcare Professionals are considered as: Social Worker, Nurse, Neonatologist, Physician, and more.

Glo Preemies Case Manager will schedule first virtual home visitation appointment within 2 weeks.

Workshop schedule will be emailed to NICU Families within 2 weeks of Intake Date.

Services can be scheduled after the family first virtual home visitation meeting.

Intake appointments do not need to be by phone or via online if the family does not require assistance. Please remind families to inform the case manager if they would like to speak by phone or via online for assistance on their intake appointment date.
