On 8/27/2025, I, Deputy B. Johnson #17543, responded to 1234 Sunshine Way for a Domestic Disturbance. The call title was later changed to Assault with Bodily Injury – Family Violence.

I arrived on scene with Sgt. Nathan Mickelson #12114. As we approached there we saw Barton, Davis Bradley W/M DOB: 2/14/1996
Daniels, Alli Jo W/F DOB: 8/22/1998
arguing under the carport.

There were several clothing type items scattered on the ground from the garage to the driveway.

Sgt. Mickelson stayed outside with Barton and I went inside with Daniels.

Daniels said she and Barton dated for about 1 year off and on. They lived together for a couple months before he was arrested about 4 months ago.

There seemed to be some sort of dispute over a dog named "Frankie" who Daniels said she adopted as a puppy well before she started dating Barton.

Daniels said she left her home last night because of disturbing messages from Barton related to the dog. She came back this morning and Barton was at her home. She asked him repeatedly to leave and he refused. He tried to get in the house, presumably to get the dog. She threatened to call the police and he left. She wasn't sure if the call went through and when I looked, I couldn't see any priors in the last 90 day for this address.

Barton came back and they argued so she called the police.

As I spoke with Daniels she kept moving her shoulder as if she was in pain. She refused EMS. At one point she lifted the sleeve of her sweatshirt and I noticed her wrist was very red. Daniels wouldn't talk about how her shoulder or wrist became injured. She did not want me to take any photos of her.

Daniels said there have been "heated" issues with her and Barton in the past but she's always gotten over it. She said he was arrested for a "terroristic charge" a few months prior for threatening to kill her, the dog, and himself. She was unsure if an EPO was put in place but thinks she got something in the mail. She completed a document to get this case dropped. She was familiar with Victim Service from the prior arrest. She did not want to speak with anyone but was open to receiving an email.

Daniels said Barton has sent threatening messages and followed her before saying it's just something that happens. When I asked about if he'd threatened suicide before she said he had if she didn't listen to him.

Sgt. Mickelson said Barton said Daniels was setting him up.

Sgt. Mickelson released Barton from the scene.

Daniels was waiting for her friends to come meet her and I told her I would wait with her as long as I could.

I was unable to run Barton to verify if there was a protective order while I was on scene. Sgt. Mickelson instructed me to conclude my call due to call volume.

As I was about to leave, I was approached by Brown, Emma W/F DOB: 7/15/2010

who showed me a video she made earlier that morning. The video showed Barton throwing things under the carport. I told her I would send her an Axon link to upload the video but I had to depart because of holding calls.

As of the writing of this report, I have not yet received the video.
