Review and Approval of September Minutes: The minutes were approved.

**Review and Approval, Correction, Edits and Approval of Agenda: Added: Recap of Achievements for the Past Year:** Board of Directors and Bylaws established; CP training program 2024 at reduced cost to students; IBSC CP exam set up with 14 more Board-Certified CPs added in Oregon; working on 501 c 3 status/ bank account; established a website and LinkedIn page (see below); legislative initiatives (ex., HB 4081/ Rep. Nosse's bills—see below) now advancing CP/ MIH work and status; grants and funding, especially for training, recruitment and retention, now exist (see below).

Legislative Updates: Madison: Rep. Nosse's office drafted bill directing OHA to create registry of MIH providers, establish billing codes\* and provide technical support. OHA "may contract with designated peer professional organization" (ORMIHC), will have \$500,000 to ensure "all the right people are at the table;" will keep this group "abreast of happenings." Stella: review of EMS Modernization Bill. \*Jonathan: use of existing codes, ex., Z codes? Madison: will start with existing codes and identifying gaps. Jonathan: HL7 International needs more mobile medical members: "latch onto this."
