**Communications:** Anne O'Connell reported that it seems that most new members seemed to understand the sign-up process for play on May 7, 2026.

A motion was made by Susan Olin, seconded by Mary Cornetta-Brown to approve the Policies and Procedures Document that was updated/amended in Nov 2025. The motion was passed by unanimous consent.

**Sunshine:** Cindy reported for Kathleen Barry that a card was sent to the Kitchen Café restaurant in Brewster to thank them for hosting/welcoming 9 Holer members for breakfast each Thursday AM during the off season winter months.

**Social:** Kathy Turieo reported she has met with Sean of Freemans Grill to discuss our food and beverage needs for our Welcome Back Coffee on June 4, 2026.

**Tournaments/Prizes:** Donna Potts reported that her committee will be meeting on 5/14/26 to discuss each members role as there has been turnover this year.

Her committee will send out an announcement the week of May 4, 2026 to all members regarding the Qualifying round of play on May 28th for the O'Connell Cup.

The new process for acknowledging Birdies and Under 50s rounds will have the Scoring committee keep track of names and dates and send the list to Donna each week.
