Secretary's Report: A motion was made by Deb Vierra, seconded by Margaret Litavis, to approve the corrected June 1, 2026 minutes. The motion passed by unanimous consent.

Treasurer's Report: Paulette Goeden reported that the balance available for operations in the 2026 Budget was \$4,366.80.

Vice President/Membership Report: Deb Vierra reported that we have 65 active members. Another new member signed up in June. There are lots of Ringers participants.

Communications: Anne O'Connell reported that all is going well with the Communications committee this past month. We had discussion about where to put our scholarship money for the 2027 season.
