

CGC Women's Nine Hole Association Board Meeting August 3, 2026

The meeting was conducted in person at Freemans Grill, Captain's Golf Course

The meeting was called to order at 8:30 a.m. by Cindy Davey.

Secretary's Report: A motion was made by Anne O'Connell, seconded by Donna Potts, to approve the corrected June 29th 2026 minutes. The motion passed by unanimous consent.

Treasurer's Report: Paulette Goeden reported that the balance available for operations in the 2026 Budget is \$4,265.44.

Vice President/Membership Report: Deb Vierra reported that we have 66 active members. If we have 50+ golfers in any given week, we will need to start tee times at 6:30 am.

Communications: Anne O'Connell reported all was good this month.

Pairings: Anne O'Connell reported that a few of the new members have been canceling using the incorrect cancellation policy/method. Joanne Cirincione shared they can highlight cancellation directions at the top of the Pairings Sheet each week. Deb will speak to any new members who may not use the correct method and Cindy will speak to any seasoned members for the same reason.

Golf Commission: Anne O'Connell reported there was no new news since our last meeting.

Scoring: Margaret Litavis asked a question to the Tournaments Committee/Donna Potts regarding the tracking sheet that collects information on members who score birdies and under 50's. This information will be noted 1x only on the sheet (not multiple times) for distribution of pins.

Website: Cindy reported for Susan Sorrento. Susan is continuing to update website with new members.

Sunshine: Cindy reported for Kathleen Barry. No news this month, however, Kathleen did express her thanks to league members for all the kindness shown to her family.

Social: Cindy reported for Kathy Turieo there was no news this month.

Tournaments/Prizes: Donna Potts reported that our Gross and Net League Championships had finished with Joanne Cirincione 1st place Gross, Michelle Litavis 2nd place Gross; Dena Connors 1st place Net, Maria Sullivan 2nd place Net. Congratulations to all! She reported it was a very successful tournament.

Donna Potts asked the question: Can a player who cancels the same week of a rainout continue to play in the tournament? All agreed yes they can.

Donna Potts asked the question: Should we continue to use the plaques as a prize? After a bit of discussion, Donna will look at other options and bring those to our August 31st meeting for a final decision.

Rally – Cheryl Villandry reported that the Rally preparations are in great shape.

Invitational: Nancy Purpura and Michelle Litavis reported on progress for the Invitational set for September 3rd. Nancy shared a handout that was a sample of the Invitation to members for sign-ups. The 2nd handout was an overview of plans/ideas in process.

Other Business:

1. Nominating Committee: Cindy appointed a nominating committee consisting of Margaret Litavis, Anne O'Connell and Donna Potts for the purpose of presenting a slate of officers at the annual meeting.
2. Donna asked that any recent deaths of previous members be shared with her group to be included in the Memorial List which will be done for the Annual Meeting in September.
3. Bylaws Revision: The board recommends amending Article II. Eligibility for Membership:
 1. As of January 1, 2012, eligibility for yearly membership in the 9-Hole Women's Association, both new and renewal, will require the following;
 - a) Membership in Captains Golf Course (or a one-year grace period approved by the Board); *or an individual who is on the waiting list to become a member of the Captains Golf Course.*
