PERSONAL INFORMATION

For the purposes of this Privacy Policy, "Personal Information", "Personally Identifiable Information" or "PII" shall mean any information that can identify or locate an individual, including, without limitation, an individuals' first and last name, residential address, email address, telephone number, race, age, gender, date of birth, IP address and social media account.

"Demographic Information" shall mean demographic information including, without limitation, income, disabilities, educational attainment, home ownership, employment status, religion, hobbies, interests, product ownership and location.

"Digital Personal Data" shall mean an individual's social media accounts, social media posts, digital images, login ID's, IP address and geolocation.

SURIIN Medical may collect Personal Identification Information from Users in a variety of ways, including, but not limited to, when Users visit our Website, when Users post comments, place an order, and in connection with other activities, services, features or resources we make available on our Website or Services. SURIIN Medical will only collect any Personal Information from Users if it has been provided to us voluntarily. Users do not have to supply personal information to us and can visit our Website anonymously.

As part of delivering our Services to Users, SURIIN Medical may have access to "Third Party Personal Information" supplied by the User, including, without limitation, an individuals' first and last name, residential address, email address, telephone number, race, age, gender and date of birth. This "Third Party Personal Information" will only be used to deliver Services as agreed with the User, subject to the condition that the collection of the Third Party's Personal Information is reasonably necessary, is utilised appropriately and does not breach any applicable laws. You represent and warrant that you have all the rights, power and authority necessary to supply SURIIN Medical with Third Party Personal Information.

We do not sell, trade, or otherwise transfer to outside parties your Personally Identifiable Information or Third Party Personal Information. This does not include trusted third parties who assist us in conducting our business so long as those parties agree to keep this information confidential. We may also release your information when we believe release is appropriate to comply with the law, enforce our Website or Services Policies, or protect ours or others rights, property, or safety.

You agree that SURIIN Medical may access or disclose your Personal Information, including the content of your communications, posts or comments, if SURIIN Medical is required to do so in order to comply with any valid legal process or governmental request (such as a search warrant, subpoena, statute, or court order), or as otherwise provided in this Privacy Policy.

NON PERSONAL INFORMATION

We may automatically collect certain non-personal information about your usage whenever you access the Website or our Services, including, but not limited to User Agent, page access and any User actions undertaken.

The collected information from SURIIN Medical is used solely internally for the purpose of gauging visitor traffic, trends and delivering personalised content to you while you are at our Website or using our Services.

DATA SECURITY

SURIIN Medical implements a variety of security measures to maintain the safety of your Personal, Third-Party and Non-Personal Information.
