

## Lexus V8 Engines LLC – Client Form

### Required Components

For a standalone engine harness service, we require the main engine harness, starter motor, knock sensor harness, and ECU to test your system once modifications are complete. If using a transfer case controlled via an actuator, the control unit must be supplied along with a pigtail.

### ✦ Important Notice:

- Connector replacements incur additional costs.
- Please ensure plastic covers on your harness remain intact to avoid extra service charges.

### Connector Requirements & Additional Costs

To create a fully functional standalone setup, some connectors may need to be added. These additional connectors are not included in the base wiring cost since each job requires different components tailored to your setup.

### Wiring & ECU Cost

The wiring harness service cost is **\$750**, which includes wiring modifications, a fuse box, and immobilizer removal (if required).

### Estimated Processing Time

Modifications typically take **10-15 business days** from when we receive your parts. However, this is an estimate—completion times may vary based on workload. While we always strive to complete modifications quickly, unexpected delays can occur.

### Pricing Breakdown 💰

- ✓ **Engine Wiring (Immobilizer removal included):** Base price of **\$750**
- ✓ **Transmission Wiring (Automatic with Cruise Control):** Base price + **\$100**
- ✓ **Transfer Case Wiring (Immobilizer removal included):** Base price **\$90**
- ✓ **Connector replacement:** Average of **\$7 per connector installed** (Varies based on connector type)
- ✓ **ECU Flashing (Manual application or trouble code removals):** **\$140**
- ✓ **Throttle response tuning:** **\$120**
- ✓ **Air Injection Delete:** **\$150**
- ✓ **Immobilizer removal (standalone ECU service):** **\$140** (If wiring service is included, immobilizer delete is part of the base cost.)
