| Service Fees for patients without a Health Card | |

| • Ontario Residents (30 days to present a valid HC for full refund) | \$40 |
| • Out of Province or Out of Country | \$60 |

| • Liquid Nitrogen Therapy (for cosmetics) | \$30 per treatment if add on - \$60 if sole reason |
| • Cosmetic Excision (Removal of any lesion not suspicious of cancer) | \$150 + \$50 per additional lesion |
| • Removal of Cosmetic Lesions (Electrodessication and Curettage or Shave Biopsy) | \$130 for 1-3 lesions + \$30 for each additional |
| • Removal of Cosmetic Lesions (Skin tags with local anesthetic) | \$100 for 1-3 lesions + \$20 for each additional |
| • Ministry of Transportation Physical and Form | \$200 |
| • Ministry of Transportation Follow Up Form (Disease Specific) | \$50 |
