## Agreement

I understand the Standard Stall terms of this application form and agree to be bound by them. I appreciate that I am working at an outdoor event which may be subject to unpredictable inclement UK weather and if the event is cancelled as a result, I clearly understand that there will be no refund due to me or compensation paid to me due to loss of earnings.

I understand that I am welcome to apply with my own stall/unit (minimum of 3 metre frontage). The formula for this is the total area price divided by 3 multiplied by metre frontage of your stall/unit. Photographs of your stall/unit must be submitted with your application.

I understand that I must have public liability insurance and that any injury, damage or loss to me or my staff, stock, vehicle or property whilst on the market site, is my own responsibility, and that by applying for a trading position I indemnify LSD Promotions against any claims or damages which may arise as a result of my own decision to trade at this event.

I understand that being granted a stall, regardless of the location allocated to me, will not guarantee that I will have a high level of sales and that I and my staff must take responsibility for display, the quality of the goods I sell, and my attitude towards customers, the event organiser & market staff, and fellow stall holders at all times.

I understand and accept that any staff member representing my stall must wear full Victorian dress at all times. Failure to comply with this rule will result in the loss of my deposit and my stall shut down.

Any trader found dumping waste into public bins will lose their deposit, be stopped from trading immediately and the right to trade with LSD Promotions in future withdrawn. The council will issue a letter to traders on opening day explaining the waste system. Further details can be found on our full terms and conditions available on the website.

I understand that this is an application at this stage and I will be notified in writing by LSD Promotions as to whether I have been accepted to trade at this event. If LSD Promotions cannot accept my application, my deposit payment will be refunded.

I understand by cancelling my application after 31<sup>st</sup> August 2018 will result in the loss of my deposit payment.

I understand and accept that full payment must be made by Friday 26<sup>th</sup> October 2018 and not making payment by this date will result in the loss of my pitch offer and loss of deposit payment.
