Thank you for applying to trade at the **Waterside Upmarket**. We are happy to confirm you have been successful in your application and your payment has been received with thanks.

TRADING TERMS AND CONDITIONS AND SPECIFIC SITE INSTRUCTIONS

- The market trades between **10am 5pm** on a **Sunday**. You can find the event location and postcode above.
- On arrival you will be greeted by a member of the operational team, who will direct you to your pitch.
- You are obliged to trade for the full duration of the event, packing away early is not accepted. You can arrive on site to set up from 7am and vehicles must be removed from the market area by 9.00am.
 For the avoidance of doubt, it is strictly prohibited to arrive to set up before 7am. The road is only closed for traders to set by between 7am-9am and again from 5pm until 7pm.
- Goods display cannot extend further into the alleyway than 1 foot (300mm) from the front leg of the stall.
- Traders cannot extend sideways from their stalls with goods/display without the consent of the market manager who will make a charge for this use.
- Under no circumstances should the trader sell products that have not been approved. Should this
 occur, this will result in formal action being taken in accordance with our trader conduct policy, which
 may result in your termination of trading. You will also be instructed to remove such products whilst
 an investigation is on-going.
- Traders are responsible to keep their stall area clean and waste/litter free. Failure to maintain a clean
 and waste free stall area will result in formal action being taken in accordance with our trader
 conduct policy.
- Electricity (max 1 kilowatt) can potentially be supplied subject to suitability for a daily charge of £5
 per stall per day. This will be a 16amp power lead into your stall. You will be responsible to connect
 to this correctly with suitable PAT tested connections and appliances. This must be pre booked and
 paid for in advance.
- Trader waste, subject to managers agreement, can be collected at a charge of £7 per stall per day.
 (Max of two average refuse sacks) This must be pre booked and paid for in advance.
- Failure to comply with any of the above requirements and/or your signed trading terms and
 conditions on your membership contract will result in formal action being taken in accordance with
 the trader conduct policy and may result in the trader's termination of trading with LSD Promotions
