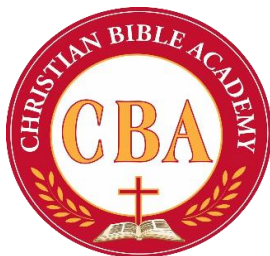

Parents/Guardians: Please review with your child.

- Demonstrate **respect to adults and peers**
- Follow this Code as if **someone is always watching**

Conduct Policy: The inappropriate behavior of a few students can have a dramatic impact on the experience of the entire group. Therefore, the following conduct policies apply directly to each individual student and will be used in determining the student's eligibility to continue attending Christian Bible Academy. All rule infractions are documented in an incident/discipline report.

A student may be suspended or released from school, without refund, for the following misconduct:

- Illegal substances
- Stealing or damaging property
- Foul language or rudeness
- Fighting
- Intentionally injuring another child
- Leaving school or classrooms without permission
- Ignoring safety rules
- Not participating in classroom activities
- Unsafe behavior during transportation

I have read the conduct policies with my child/children, and we understand the consequences of not complying with the rules. I also understand that I could be suspended from school if I violate any serious infractions. I also understand that these rules are not to discourage fun and learning but to promote and encourage a safe and healthy environment. Discipline and Guidance Policy

Christian Bible Academy (CBA) follows the discipline and guidance standards outlined in the Texas Minimum Standards for childcare centers, Section 746 and 747, Subchapter L. These policies apply to all adult caregivers, including parents and guardians, while on the Christian Bible Academy campus.

Acceptable Discipline Practices

Discipline must always be:

- Individualized and consistent for each child
- Appropriate to the child's level of understanding
- Focused on teaching acceptable behavior and self-control

Caregivers may use only positive methods of discipline that support self-esteem, self-control, and self-direction, including:

- Praise and encouragement of appropriate behavior
- Clear, positive daily reminders of behavior expectations
- Positive redirection of behavior
- Brief, supervised, age-appropriate time-outs (not exceeding one minute per year of age)

Prohibited Discipline Practices

Harsh, cruel, or unusual treatment of any child is strictly prohibited. The following actions are not allowed:

- Corporal punishment or threats of it
- Punishment involving food, naps, or toilet training
- Grabbing, pulling, or physically restraining a child
- Forcing anything into or onto a child's mouth
- Humiliating, ridiculing, rejecting, or yelling at a child
- Using harsh, abusive, profane, or demeaning language
- Confining a child in a locked or dark space
- Using restrictive devices for time-out
- Withholding active play as punishment, except for brief, supervised, age-appropriate separation when necessary
- Requiring silence or inactivity for unreasonable periods based on the child's age

Violation of these policies may result in state auditing or investigation of the facility and/or the adult involved. My signature affirms that I have received, read, and understand the Discipline and Guidance Policy.
