Camden's Policy is that during this difficult time we will make all PPE mandatory. Zero tolerance.

Face Shields/Masks, Hard Hats, Safety Glasses and Glass Gloves or Nitrile Gloves are to be worn at all times.

Each Foreman will have Sanitizer readily available in site job boxes.

All site equipment, (saws, chains, locks, tools, ladders, scaffolding, job boxes) are to be wiped down with disinfectant at the end of each work day.

Tools are to be placed into the job boxes to prevent contamination. No tools are to be loaned out at any time to anyone. If you are to change sites for the next day you are to disinfect your own personal tools before leaving/entering the jobsite.

Before and after each use, every hard hat should be inspected for any wear or damage that might have accrued. A general inspection process should be:

- **1.** Look at the shell of the hat for any breakage, cracks, craze patterns, discoloring, chalky appearance, or anything that appears out of the norm.
- 2. Inspect the suspension for loss of flexibility, cracks, breaks, frays, or damaged stitching.
- 3. Ask the worker wearing the hat if any impact or penetration occurred during their time using it.

4. If any of these conditions exist, replace the suspension or shell immediately (MSA 2010).

Gentlemen,

This week's safety talk mandatory subject will be Noise.

Noise-induced hearing loss (NIHL) is a leading cause of occupational disease for Ontario workers. According to the Workplace Safety and Insurance Board work-related illness claims including the number of claims resulting from occupational NIHL have continued to increase overall in the last 10 years.

The new regulation is in keeping with changes proposed by the MOL in 2014. A 60-day public consultation was held from October 28 to December 29, 2014.

The new noise regulation retains the following requirements:

- Prescribes, for workers exposed to noise, a maximum time-weighted exposure limit of 85 decibels over an eight-hour work shift; and
- Requires employers to put in place measures to reduce workers' exposures based on a "hierarchy of controls" which could include engineering controls, work practices, and the use of personal protective equipment in the form of hearing protection devices.

Screwdrivers do make good door stops and pry bars work decently at forcing in rubber but how many times have we all had a tool break from improper use and end up stabbing ourselves in the hand or worse?

We have all used ladders to cut setting blocks on while we sat on them.

What we need to focus on is doing our best to avoid the wrong tool in these situations.

We should keep our tools clean, replace when needed, we should maintain the tools often.

Check power cords make sure the ground is good, wires are not exposed.

Let your Foreman know when you need a tool replaced and we can all help each other work safer.

Please make sure that the proper paperwork is requested (FAF), the letter to worker is to go with the injured person before they leave site. This is to be filled out by the doctor or medical staff and returned.

Unsafe Acts and conditions:

- 1. Unauthorized use or operation of equipment
- 2. Failure to secure or tie down materials while moving or failure to store materials properly
- 3. Working or operating equipment in a rush
- 4. Failure to issue warnings or signals
- 5. Using defective tools, equipment or unlabeled/incorrectly materials
- 6. Removing Guards, loose clothing or brakes intended on saws
- 7. Using tools incorrectly or unsafely
- 8. Standing in an unsafe place, messy area's or improper posture while lifting
- 9. Trying to fix equipment while in operation
- 10. Riding equipment not designed for passengers
- 11. Horseplay, poor lighting

Please cover the following information during your session:

Please explain the dangers of working in the winter. Cold Stress, Hypothermia, Frostbite, Slips, Falls and Carbon Monoxide (CO).

Identify ways to control or avoid these dangers.

- 1. Wear several thin layers instead of just one heavy thick layer
- 2. Wear gloves as well as a hat.
- 3. Wear two pairs of thin socks. Etc...

Prevent Slips and falls

- 1. Clean ice and snow off your boots, access areas and work platforms.
- 2. Use sand, salt or other de-icing materials.
- 3. Try to keep a hand free to help keep your balance.

Prevent exposer to CO gas.

- 1. Use indirect-fired heaters when in enclosed spaces.
- 2. Check propane heaters for leaks and make sure they are vented properly.
- 3. Choose electric equipment when you can.

Canadian winters are difficult enough take the steps necessary to be safe, a slip on the ground can cost you weeks off work, a slip at height can cost you your life.

Please discuss how wearing the right protection (PPE) can save your workers from being injured.

As per construction regulation 25 – A worker shall use protection appropriate in the circumstances when there is a risk of injury on a project from contact between the workers skin and, (b) an object that may puncture, cut or abrade the skin;

Protecting your eyes is the easiest thing to do.

We have safety goggles, glasses and face shields available for anyone who requires them.

Gloves and working safely should be considered at all times while operating chop saws.

Some job sites and GC's may have a mandatory policy that we should follow their procedures when on their site.

Common sense should be the biggest factor in when you should wear them.

Saws are not to be greased while the saw is plugged in. Please lock out to your best ability to create a safer environment for your workers.

Please make sure workers are trained properly in use of the chop saw. A safe environment for all workers onsite is what we strive for. Please also consult your Blue Book for best practices in using equipment if you are unsure or call me directly.
