AUTHORIZATION SHEET

1. I authorize Swaggy Waggy Pet Sitting Services LLC to obtain any emergency veterinary care that may be necessary during the time spent with my pet. I accept responsibility for any charges related to this emergency care. I also authorize Swaggy Waggy to utilize an alternative veterinarian in the event my regular veterinarian is unavailable. Every effort will be made to contact the owner prior to obtaining emergency care.
2. Swaggy Waggy accepts no responsibility for security of the premises, or loss, if other individuals have access to the home during the term of this agreement. Pet care will be performed only by Swaggy Waggy during all assignments unless pre-arranged with a client (i.e. in the event of Swaggy Waggy Dogs owner or employee being on vacation, etc.)
3. I agree to reimburse Swaggy Waggy for any additional costs arising from providing emergency care, as well as expenses incurred for unexpected visits, transportation, housing, food, medications, or other supplies.
4. Swaggy Waggy agrees to provide the services stated in this agreement in a reliable, caring and trustworthy manner. In consideration of these services and as an express condition thereof, the client expressly waives and relinquishes all claims against Swaggy Waggy, its employees or assigns, except those arising from negligence of the pet sitter. Swaggy Waggy is not responsible for damage incurred by pet escaping because of a faulty leash/collar or a collar that is not properly fitting.
5. Swaggy Waggy will not be liable for the injury, disappearance, death, or fines of any pet with unsupervised access to the outdoors.
6. Client will be responsible for all medical expenses and damages resulting from an injury to the pet sitter, or other persons, by the pet. Client agrees to indemnify and hold harmless Swaggy Waggy in the event of a claim by any person injured by the pet.
7. This agreement is valid for all future visits until a new agreement is signed. Swaggy Waggy reserves the right to terminate this agreement at any time, at its sole discretion; likewise, client may terminate this agreement at any time. There is no term of contract for daily dog walking.
8. It is expressly understood that Swaggy Waggy shall not be held responsible for any damage to clients property, or that of others, caused by clients pets during the period in which they are in its care. Client has advised Swaggy Waggy of all situations, which will relieve it of liability for damage

Client understands that Swaggy Waggy will retain a copy of their key and alarm code (when applicable). Swaggy Waggy may enter premises to perform pet sitting duties. Swaggy Waggy may not make copies of the key without express consent of the client. The client may request the return of their key at any time.

9. In the case of home boarding, the client affirms that their pet is clean and on flea and tick control. The client will provide food, medication, and other comforts (bed, toys, etc.) that the pet may require. The client agrees to pick up their pet at the scheduled time or contact Swaggy Waggy to extend the boarding time. The client understands that if they fail to pick up their pet or contact Swaggy Waggy within five (5) days of the pick up time, Swaggy Waggy will

consider the pet abandoned and may surrender the pet to the local humane society or Animal Control Office at their discretion.
