**Enrollment Agreement**  
**August 16, 2023-May 17, 2024**

THIS AGREEMENT is entered into by and between Casa dei Montessori ("school") and the parent or guardian ("parent") whose signature appears below.

The parties hereto accept the following terms and conditions governing the child's enrollment at the Montessori school.

1. The parent agrees to enroll his or her son/daughter, \_\_\_\_\_ in the school program that begins August 16, 2023 and ends May 17, 2024.
2. The parent agrees to follow and adhere to the policies, rules and regulations of the school as currently set forth in the Parent Handbook and other such rules and regulations as may be promulgated hereafter by the school.
3. The parent agrees to pay the tuition and all fees for the Program in which his or her child is to be enrolled in accordance to announced rates.
4. Upon the signing of the Agreement, the parent agrees to pay the school a \$200 Acceptance fee and the Supply fee that corresponds with the program chosen on the Payment Schedule, which are nonrefundable.
5. The parent understands and agrees that the child is enrolled from August 16, 2023 through May 17, 2024 and the parent is liable for the entire tuition and fees upon signing the Agreement.
6. The parent further agrees that the withdrawal or dismissal of the child after the execution of the Agreement, whether as a result of accident, transfer, sickness, COVID 19, or otherwise, does not relieve the parent of the responsibility for the entire tuition.
7. Tuition payments are due in accordance to the fees stated on the Tuition Payment Schedule. Failure to pay these fees by the specified dates will result in a 10% monthly late fee.
8. The fact that the school allows tuition and fees to be paid in two or more installments does not create a fractional contract or in any way relieve the parent of responsibility for the entire tuition amount. Parent further agrees that the total amount due and payable to the school shall be considered as agreed upon liquidated damages between the parties to this Agreement.
9. The parent agrees that if payment of tuition is not made in accordance with this agreement, the school shall have the right to refuse to admit the child to class. Furthermore, if this Agreement is breached the school shall be entitled to collect reasonable attorney fees and all costs for enforcing this Agreement.
10. Parent understands and agrees that the duties and obligations of the school under this Agreement may be modified or suspended immediately and without notice because of force majeure causes beyond the school's reasonable control and occurring without it's fault or negligence including, but not limited to, acts of god, fire, wars, governmental action, terrorism, epidemic, pandemic, or any other event beyond the school's control. I acknowledge and agree that my obligations under this contract, including but not limited to, obligation to be financially responsible for the student's tuition and other fees, shall continue, and the school's duties and obligations may be modified, suspended or postponed until such time as the school, in its sole discretion, may safely resume operations. I acknowledge and agree that the sole remedy for a force majeure event is future service delivery and not a financial refund. The school may, at its option, alter the academic year or provide alternate means of instruction in the school's discretion.
11. This Enrollment Agreement is not binding until executed by the school and is for the period of August 16, 2023 through May 17, 2024.
