4. The association will take every precaution in its power for the protection of exhibits but cannot be responsible for any loss or damage that may occur in the delivery, exhibition, or removal of exhibits.
5. **Return a copy of this signed rental agreement with your payment an Operator Certificate of Compliance form and copy of Liability Insurance**
