<b>Maralago Cay</b> <b>6280 South Ash Lane</b> <b>Lantana, FL 33462</b>	...on 95 take exit 61 (Lantana Road) – head West. Take a left on Lawrence Road. Maralago Cay will be your 2 <sup>nd</sup> right. Courts are behind the pool / activity building ahead.
<b>Briny Breezes</b> <b>5000 N. Ocean Blvd</b> <b>Briny Breezes, FL 33435</b>	...on 95 take exit 56 (Woolbrite Rd.) – head East. Go over Intercoastal bridge and at light, take a right. Go through next light and at next road (Ruth Mary), take right for parking.
<b>Century Village</b> <b>Century Blvd. (@ Clubhouse)</b> <b>Deerfield Beach, FL 33442</b>	...on 95 take exit 42B (Hillsboro Blvd.) – head West. Pass Military Trail and at next light, (Century Blvd.) take a left. Courts are on left about ¾ mile from security gate.
<b>Pompano Beach</b> <b>2250 E. Atlantic Blvd.</b> <b>Pompano Beach, FL 33062</b>	...on 95 take exit 36 (Atlantic Blvd.) – head East. Just after passing Rt. 1, courts are on your right. Take right on SE 23 <sup>rd</sup> Ave. for parking.
<b>Park City</b> <b>SW 87<sup>th</sup> Terrace</b> <b>Davie, FL 33324</b>	...on 95 take exit 26 (595) – head West. Take Pine Island Rd. exit. Stay in left lane to take first left before light for U-Turn. On other side of bridge, cut across to right lane immediately for turn onto SW 86 <sup>th</sup> Ave. At SW 21 <sup>st</sup> St. take a right. Courts are on right.
<b>Hollywood</b> <b>301 N. 21<sup>st</sup>. Ave</b> <b>Hollywood, FL</b>	...on 95 take exit 20 (Hollywood Blvd.) – head East. Just after crossing railroad tracks, take a left onto 21 <sup>st</sup> Ave. Courts are on your right. Turn right onto Polk St. for parking.
