**Meadow Lake Resort Boat Club Membership**  
**PRIVILEGES, RULES & WAIVER**

**Boat Club Membership Fee (2 Options)**

1. **Yearly:** \$100 paid annually per vessel, once Member's application is approved. Annual term runs September 1<sup>st</sup> thru August 31<sup>st</sup> of the following year. No proration of fee for partial year. Fee is non- refundable. Allows for **Unlimited launching of the vessel from the Resort Boat Launch for the year**; OR,
2. **Pay As Go:** \$20 paid per vessel for Club Membership fee and 1<sup>st</sup> launch, once Member's application is approved. **Each time thereafter, the Member pays a fee of \$10 for each launch.**

**MEMBER PRIVILEGES:**

- (1) 1 Meadow Lake Resort Boat Club sticker, which must be affixed to the vessel next to the TX Registration #;
- (2) 1 Resort Guest Parking Pass for one tow vehicle and trailer used to launch the vessel. Pass must be present and viewable on vehicle when it is parked. (Yearly Member keeps the same Guest Parking Pass which is valid for the Annual Term. Pay As Go Member must get a new Guest Parking Pass each visit);
- (3) Entrance of Four (4) people through the Resort to access the vessel at the Resort Boat Launch. This does not include use of other Resort accommodations; and
- (4) Discounted fee for Boat Club sponsored Events (i.e. fishing tournament).

**MEMBER RULES AND RESPONSIBILITIES:**

- (5) Must follow all state, local, and federal boating laws
- (6) Financially responsible for damage done to Resort Property. Also, if the tow vehicle and/or trailer get stuck, they will be towed at the owner's expense. Any damage caused to the ramp, or any Meadow Lake Resort property, from the tow vehicle and/or trailer will be repaired at the cost of the boat owner
- (7) Tow vehicle & trailer must be parked in designated Parking Area.
- (8) Must contact Meadow Lake Resort Office regarding use of other Resort amenities. The Office will advise of any additional cost.
- (9) Only Boat Club members may launch boats
- (10) Operators are responsible for their passengers and guests following Boat Club rules.
- (11) Members are responsible for providing the required number of PFDs per boat.
- (12) Must consider the safety of others at all times.
- (13) Must refrain from annoying fisherman either in boats or on the shore.
- (14) Must abide by a speed limit not to exceed 3 MPH, or to create a wake, by the Resort dock channel.
- (15) Kayaks, paddleboats and canoes have the right of way at all times
- (16) Boat and trailer must have been pressure washed and dried for at least 5 days after being used in any waters other than Meadow Lake. MLR reserves the right to inspect the vessel.
- (17) MLR reserves that right to void any Membership at any time.

**MEMBER WAIVER:**

Meadow Lake RV Resort, LLC, d/b/a Meadow Lake Resort ("MLR"), and its employees, agents, successors and/or assigns, shall not be liable for any damages whatsoever, including property damage or personal injury to the boat owner, its agents, employees, guests, successors and/or assigns, which may occur on or about any part of MLR boat launch being used for the launch or removal of a boat, regardless of how such injury or damage may have occurred. The boat owner waives any claim against MLR for any liability, damages or expenses arising out of any claim for injury or damage to any person or property of any kind whatsoever, together with all costs in connection with the defense, including attorney's fees. The boat owner agrees to indemnify and hold MLR, its employee, agents, successors and/or assigns harmless in regards to any injury or damage to any third party or property resulting in whole or in part from the boat owner's use of or presence at the MLR's boat launch site or property. MLR reserves the right to refuse use of the boat launch or any other MLR amenities, as it deems appropriate.
