# OFFICIAL TRANSCRIPT OF THE PROCEEDINGS OF THE GRANT VALLEY TOWN BOARD OF SUPERVISORS MEETING OF Thursday, March 20th, 2025.

The Grant Valley Town Board of Supervisors met for their regularly scheduled monthly business meeting on Thursday, March 20th, 2025 at the Grant Valley Town Hall.

Board Members present were, Chairman Hiltz, Supervisor Hiltz, Treasurer Slough, Clerk Stevens, and Road Supervisor Christianson and Wes Hegna, Assessor.

Chairman Hiltz welcomed everyone and called the meeting to order with the pledge to the flag at 7:00 pm.

#### **APPROVAL OF MINUTES:**

Supervisor Hiltz made a motion to approve the February 13<sup>h</sup>, 2025, Regular Meeting, seconded by Supervisor Eckman and carried on unanimous roll call vote.

#### TREASURER'S REPORT:

The bills were reviewed and discussed. Supervisor Hiltz made a motion to pay the bills as presented seconded by Supervisor Eckman and carried by unanimous roll call vote.

## NEW BUSINESS:

Bob Hiltz took the Oath of Election and signed the certificate of election.

Appointments of Board Members- Chairman Hiltz will do Rural Fire Association and Roads, Bob Hiltz will do Animal Control and Jayzb, while assisting with roads, and Marlys Eckman will do BATO. Supervisor Eckman made a motion to appoint Russel Hiltz as Board Chairman, and Marlys Eckman as Vice Chair, seconded by Supervisor Hiltz and caried by unanimous roll call vote.

Chairman Hiltz made a motion to set road tour April 26<sup>th</sup> at 8 am, seconded by Supervisor Hiltz and carried by unanimous roll call vote. Clerk Stevens will post in paper.

Short course is April 2<sup>nd</sup> Chairman Hiltz made a motion to pay for the dues for meeting and meeting rates, seconded by supervisor Eckman, carried by unanimous roll call vote.

Discussion of new flag, Supervisor Eckman made a motion for Keith to purchase a new flag, seconded by Supervisor Hiltz and carried by unanimous roll call vote.

Wes Hegna, assessor was invited to a meeting to check in with the Board Members. Beltrami County is going digital, Wes Hegna will be able to take photos of properties in the future unless home owner's decline. He will be down every driveway within 5 years. Wes Hegna would apricate updates if we know about new construction. Discussion on the area and his travels throughout the Township.
