LEAP Business Group Policies

Attendance: Members should attend every meeting possible. Maintain a 75% attendance per quarter, approximately 3 absences a quarter. If you miss 5 consecutive meetings, your seat will be subject to being vacated and become open/available, unless absences are approved by the LEAP Leadership and/or Board. You may send someone in your place to represent only your company. Representation: You may only represent one company.

Membership: To become a member, you need to follow these steps: Attend six meetings within an eight-week period. Complete four one-on-one meetings with current members, two of which must be with a member of the leadership team. After receiving approval from the leadership team, pay the first annual pro-rated membership dues, which will be determined by the treasurer.

To maintain your membership, you must: Attend at least 75% of the meetings. Bring two guests per quarter. Pay \$150 in yearly dues.

Participation: Each member should actively participate by scheduling 1-on-1's with other members. Each member should participate by bringing guests. Each member should participate by promoting other members on social media (Facebook, Linked In, and Meetup)
