

Athletic Liability Release and Waiver

In consideration of being allowed to participate in any way in California Prestige University's athletic sports program, related events, and activities, the undersigned acknowledges, appreciates, and agrees that:

The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death. In addition, the risk of contracting other contagious diseases due to the nature of the physical interaction required in the activities involved in this program is also significant. While particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury, sickness, and death does exist.

The PARTICIPANT knowingly and freely assumes all such risks, both known and unknown, and understands that he/she is personally responsible, agrees to indemnify, defend and hold harmless California Prestige University, its officers, coaches, volunteers, students and employees from any action, claim, or demand that the PARTICIPANT, his/her heirs, or legal representatives have or may have for any and all personal injuries he/she may sustain and/or diseases he/she may contract, regardless of cause or fault, as a result of his/her voluntary decision to participate in the PROGRAM.

The PARTICIPANT willingly agrees to comply with the stated and customary terms and conditions for participation. If, however, the PARTICIPANT observes any unusual significant hazard during their presence or participation, the PARTICIPANT may remove himself/herself from participation without penalty or sanction from California Prestige University.

The PARTICIPANT, his/her heirs, and legal representatives hereby release and discharge California Prestige University, its officers, coaches, volunteers, students and employees (hereafter "Released Parties") from any and all claims which may arise from any causes whatsoever, including any negligent act or omission by the Released Parties. The PARTICIPANT further releases and discharges the Released Parties from liability for any accident, illness, injury, loss or damage to personal property, or any other consequences arising or resulting directly or indirectly from the PARTICIPANT's participation in the PROGRAM.

I HAVE READ THIS ATHLETIC LIABILITY RELEASE AND WAIVER, FULLY UNDERSTAND ITS TERMS, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT. I ALSO FULLY UNDERSTAND AND ACCEPT THAT California Prestige University IS NOT RESPONSIBLE MEDICAL INSURANCE COVERAGE OR ANY MEDICAL EXPENSES AND THAT THE PARTICIPANT CANNOT PARTICIPATE IN ANY PROGRAM-RELATED ACTIVITIES WITHOUT PROOF OF INSURANCE.
