GENERAL RULES AND INFORMATION

Welcome to The Fifty-Ninth Annual Arrowhead Open Championships, sanctioned by U.S. Figure Skating and is open to all U.S. Figure Skating registered eligible persons.

COMPETITION OVERVIEW

The Fifty-Ninth Annual Arrowhead Figure Skating Club Open Championships will be conducted in accordance with the rules and regulations of U.S. Figure Skating, as set forth in the <u>current rulebook</u>, and/or current Compete USA handbook as well as any pertinent updates that have been posted on the U.S. Figure Skating <u>website</u>.

This competition is open to all eligible, restricted, reinstated or readmitted persons as defined by the Eligibility Rules.

Skaters must be a currently registered member of a U.S. Figure Skating member club, Learn to Skate USA® member, a collegiate club or who is an individual member in accordance with the current rulebook. For non-U.S. citizens, please refer to the <u>rulebook</u> for more information.

SERIES INFORMATION: So-Cal Interclub Invitational Series

The 59th Annual Arrowhead Open Championships has been approved as part of the 2025 Southern California Interclub Invitational Series. Top point scorers at the end of the season will be invited to the Invitational Series Final. DOUG AUSTIN BEST PERFORMANCE AWARD: This special award will be presented for the best performance of the competition. All competitors will be judged by a special panel of judges. This award will be presented at the close of the competition. The perpetual trophy will remain with the club and a "take-home" trophy will be awarded to the winner.

REGISTRATION INFORMATION

Entries must be made on-line through EntryEeze no later than

MONDAY, OCTOBER 7, 2024, 11:59 pm.

REFUND POLICY

No entry fee will be refunded if a skater withdraws from an event after closing date of entries. Entry fees will not be refunded after the entry deadline unless no competition exists or the event is canceled. There will be no refunds for medical withdrawals.

Late entries MAY be accepted at the discretion of the LOC and will be subject to a \$25 late fee.

The host club reserves the right to close registration at any time if event capacity is met

Skaters and their coaches are responsible to ensure skater is registered at the correct level.

Absolutely no event level changes will be made after FRIDAY, OCTOBER 18, 2024, 11:59 pm.

All events are separate, unrelated events. There are no age requirements except as noted.

Two entries in any event constitute a competition.

In an event where only one entry is received, an entrant may move up one class, regardless of test qualifications.

If there are not enough entries to hold an event, boys and girls may compete against each other at the Pre-Juvenile level and below. If there is still no competition, the skater may compete in a single-entry event or receive a refund.

Should the number of entries warrant more than one group at a level, skaters will be divided by age. There will be no final rounds.

Compete USA events will follow parameters outlined in the current Compete USA Competition Manual

Showcase disciplines may be combined at the discretion of the chief referee

The decision of the Referee and the Competition Committee on all matters will be final.

Any change in the championship rules or schedules will be posted on the EntryEeze website and on the official bulletin board in the rink and shall be considered sufficient notice to all competitors and officials.

II. ELIGIBILITY

Singles: Excel and Well-Balanced Events:

- Skaters must meet at least the minimum singles test requirements for the event's level. A skater's singles test level may be higher than the minimum requirement.
 - o Skate Up -- Skaters may skate up one level higher than their minimum test requirement allows.
- Skaters may not register for an event level lower than allowed by their competitive floor. An athlete's competitive floor is set by one of the following scenarios:
 - o If an athlete has a paid EMS series application for the NQS series, the event level registered for in the most recent NQS will become the lowest level they may compete at in any U.S. Figure Skating sanctioned event.
 - o If an athlete has a paid EMS series application for the Excel Series, the event level registered for in the most recent Excel series will become the lowest level they may compete in any Excel event. For Well-Balanced and Specialty events the skater will be permitted to register at one level lower than the "floor" set by their excel series entry.
 - o If an athlete has never had a paid EMS series application in the NQS or Excel series, the athlete may select their level based on their goals and technical skills as long as the minimum test requirements are met.
- Skaters are not permitted to enter an Excel free skate and a Well-Balanced free skate event at the same competition (example: Juvenile Girls Free Skate and Juvenile Girls Excel Free Skate). However, they are permitted to enter an Excel and a Well-Balanced event of different types such as a short program (if stand-alone event option), specialty or showcase events (example: Intermediate Women Short Program and Intermediate Women Excel Free Skate).

All other singles and partner events:

Skaters must meet the minimum test requirements for the events level, but not exceed the maximum permissible test requirement. See current rulebook for updated rules and requirements.

EVENT: Excel Free Skate Program

A. Skaters will skate to the music of their choice. Vocal music is permitted at all levels.

EVENT: Well Balanced Free Skate

General event parameters:

A. Skaters will skate to the music of their choice. Vocal music is permitted.

EVENT: Adult Free Skate

Adult events will be conducted in accordance with the U.S. Figure Skating rulebook. Athletes and coaches are responsible for going to the U.S. Figure Skating rulebook for rules, program length, etc.

EVENT: Basic Program: SNOWPLOW SAM – BASIC 6.

Format: The skating order of the required elements is optional. The elements are not restricted as to the number of times the element is executed or length of glides, number of revolutions, etc., unless otherwise specified.

- A. To be skated on full ice.
- B. The skater may use elements from a previous level.
- C. A 0.2 deduction will be taken for each element performed from a higher level.

EVENT: Aspire 1-4:

Format: The skating order of the required elements is optional. The elements are not restricted as to the number of times the element is executed or length of glides, number of revolutions, etc., unless otherwise specified. (Note: Aspire program replaced the Pre-Free Skate – Free Skate 6 Program)

- A. To be skated on full ice.
- B. The skater may use elements from a previous level.
- C. A 0.2 deduction will be taken for each element performed from a higher level.

SHOWCASE EVENTS:

The following categories of singles/showcase events will be offered:

The Component Judging System (CJS) will be used for Showcase Events.

The 6.0 Judging System will be used for Compete USA Showcase Events.

- B. Standard Events
- C. Adult Events

Note: Snowplow Sam events are limited to Lyrical Pop and Character Performance.

Emotional Performance:

Programs should portray a story, expressing conflict, resolution and/or depth of emotion. Skater should provoke an emotional response with the audience - through related skating movements, gestures and choreographic processes. The entire spectrum of emotions should be considered when selecting the theme (e.g. love, loss, longing, fulfillment, happiness, melancholy, sadness, etc.).

- Lip synching is not permitted.
- Props and Scenery are permitted.
- No Technical Limitations.

Character Performance:

Skaters will impersonate a character, original or adapted, on the ice. Performances as a character from a movie, musical, book, original idea, and original adaptation are all welcome here.

- Lip synching is required
- Props and Scenery are permitted
- No Technical Limitations

Comedic Impressions:

A humorous performance intentionally designed to achieve continuous/multiple chuckles, laughs, or audible rises from viewers. Performance is projected outward towards audience and entertaining through skating movements, gestures and physical actions deemed comedic.

- Lip synching is permitted
- Props and Scenery are permitted
- No Technical Limitations

Lyrical Pop:

Perform to your favorite song containing lyrics, without lip-synching.

- Lip synching is not permitted
- Props and Scenery are not permitted
- No Technical Limitations

Duets/Trios: (Team Event – Special Registration Process)

Theatrical/artistic performances by 2 to 3 skaters. Lip Synching, Props, and Scenery ARE permitted. Skaters may enter only one duet/trio. (Spotlights will not be used for this event)

For the Duets/Trios Event: One Individual will need to register each team separately and pay for that team (all members together) in the online system. When you register the team, you will need to provide the following information:

- a. "Team Contact" this will be the contact information for a primary person who will be responsible for the team
- b. "Team Name" this will be the name of the team used on the skating orders and in the program
- c. Number of team members and will be the basis of the per member charge for the event
- d. The team roster for each of the team members, you will need the following information:

- Skater first and last name
- Skater date of birth
- Skater highest test passed
- Skater USFS number
- Email address of the skater if over 18 or the email address of the skater's legal guardian if under 18 so that they can accept the liability waiver for that skater

MUSIC SUBMISSION/UPLOAD:

MUSIC: Online music submission is the ONLY acceptable method to submit program music. After you have paid for your events, the system will prompt you to upload your music for each event that requires music. If your music is not available at that time, you can logout of your account and return later to upload your music by going to the "Competition" tab and then selecting "My Music". Please be sure you are uploading the correct music for the correct event segment. Be careful, for example, not to mix up your short program and your free skate!

MUSIC UPLOADING DEADLINE: FRIDAY OCTOBER 18, 2024 11:59 PM

The uploaded program music MUST conform to the following specifications:

Programs per file: One (1) - Only one piece of competition program music (e.g. short program, free skate, short dance, free dance, etc.) per file is allowed.

File Format: mp3 - The uploaded file music must be an mp3 file (MPEG-1 or MPEG-2 Audio Layer III).

Simply changing the file extension to "mp3" from another file format is not acceptable.

Bit Rate: 192 kbps is requested (bit rates between 128 and 320 kbps will be accepted).

Maximum file size: 10 MB

Maximum run time: Five (5 minutes)

ID3 Metadata (tags): None - The Chief Music Coordinator strongly recommends that mp3 files DO NOT contain any ID3 metadata, commonly called tags. This is especially true of any embedded images such as album cover art, picture of the skater, etc. Please, NO EMBEDDED IMAGES!

Maximum leader: Two (2) seconds - The leader is the silence between the start of the track and the actual start of the program music. The Chief Music Coordinator recommends that there be NO leader.

Maximum trailer: Two (2) seconds - The trailer is the silence between the end of the program music and the end of the actual track. The Chief Music Coordinator recommends that there be NO trailer.

Backup Music at Event (CDs): In addition to submitting the music online, all competitors/teams must also have at least one (1) backup copy of their competition music on CD, AT RINKSIDE, during the actual competition event or official practice. CDs must meet the following requirements:

- In standard Audio CD format (Compact Disc Digital Audio). Other formats, including mp3 are NOT acceptable.
- Clearly marked with a permanent marker (e.g. Sharpie, do NOT use a label or tape) as follows:

First Name, Last Name, (Club – Optional but requested), Event, Event Segment and Music Length (e.g. Jane Smith, Acme FSC, Novice Ladies, Free Skate, 3:10 or Synchro Team, Widget FSC, Preliminary, Free Skate, 1:59)

- Each CD may have only ONE (1) music track on it. In the case where a skater competes in both a short program/dance and a free skate/free dance, two (2) separate discs must be available. Any disc with more than one (1) track is NOT acceptable.
- Lead in time (time before the music begins) on CDs may not exceed two (2) seconds.
- Due to the compatibility and reliability reasons, music may NOT be submitted on re-recordable "CD-RW" discs. PLEASE, no CD-RWs!!

Backup Music at Event (PHONE): Competitors MAY, as an alternate, have available a backup copy of their competition music on a cell phone and it must be immediately available rink side whenever the skater competes. If the phone does not have the standard round headset connector, an appropriate adapter, such as an Apple Lightning connector or Samsung USB-C adapter is required to be attached. The phone should be presented to the music person with the file ready to play, phone in airplane mode and volume turned to maximum.

The LOC, competition officials, and volunteers exercise reasonable care when handling CDs. However, they are not responsible for damage to or loss of any CDs. The LOC is not responsible for CDs not picked up by the end of the competition and they will be destroyed.

Penalty for Incorrect Music or Failure to Upload Music: The LOC may assess each competitor/team an additional charge, up to \$25.00 per event segment, if the competitor/team:

- 1) Fails to submit their music prior to the close of online music submission,
- 2) Submits files that do not follow the specifications above, or
- 3) Uploads the incorrect music for a given event segment (e.g. uploads short program music instead of the free skate).

In the event the LOC decides to assess a penalty, the competitor/teams will not be checked in until they pay the penalty fee and turn in their music on CD, conforming to the requirements above.

If there is an issue with the downloaded music or CD provided at the event after the skater's name has been called to compete, the skater will have up to 3 minutes to rectify the situation with a backup copy of the music on CD or Provide Phone with music cued up. After 3 minutes, the skater will be considered withdrawn.

COACHES

To be an eligible coach at a nonqualifying competition, coaches must meet the applicable compliance requirements and verified by U.S. Figure Skating. Coach compliance falls into two categories, Coach Compliance (includes choreographers) and Learn to Skate USA® Instructor Compliance. Details regarding compliance requirements can be found HERE. All compliance requirements must be met at the time of check-in to access the competition, no exceptions.

- U.S. Figure Skating Full Membership (either through a member club or as an individual)
- Completion of the U.S. Center for SafeSport's online SafeSport™ Training
- Successfully pass a bi-seasonal background check (includes automatic recheck at the 12-month mark)
- Agree to the U.S. Figure Skating Code of Ethics
- Verification of liability insurance Completion of CER Courses (administered via PSA)
- Agree to Waivers and Release
- Agree to Medical Consent
- Agree to Name and Likeness Release
- PSA Membership (if coaching in qualifying competitions)

<u>Coaches of foreign athletes:</u> If you are a coach of a foreign athlete only, you are not subject to U.S. Figure Skating coach compliance and will only be asked to provide a letter of good standing for the federation your athlete represents.

MANDATORY ATHLETES

If You will be 18 or older before competition day, and you are in a Duet/Trio Showcase

Athletes age 18+ as of the competition start date who will be competing on a team (i.e., synchro, ice dance, pairs, showcase, theatre, etc.) with at least one Minor Athlete must complete SafeSport™ Training.

Minor athletes who turn 18 mid-season are encouraged to seek parental consent to take the online SafeSport™ Training early to avoid any disruptions in their ability to participate as the training is required upon turning 18. The athlete will not be compliant until they have completed the training and their Members Only portal reflects completion. Please email skatesafe@usfigureskating.org for instructions or questions regarding parental consent.

LIABILITY:

U.S. Figure Skating, Learn to Skate USA®, Arrowhead FSC and Ontario Ice Skating Center accept no responsibility for injury or damage sustained by any participant in this competition. This is in accordance with Rule 1600 of the official U.S. Figure Skating Rulebook.

IV. COMPETITION DETAILS

FACILITIES:

Rink has some vending machines, but no snack bar. <u>We recommend you bring snacks and water</u> <u>for your group.</u>

LOCKER ROOMS AND CHANGING AREAS:

Locker rooms and changing areas at U.S. Figure Skating competitive events are for athletes only, will be labeled with regard to specific use and where identified will be gender specific. An exception can be made for athletes under 11 years old that will allow for one parent of the same sex to assist their child immediately prior to and after their skating event(s). Please review the Locker Room and Changing Area Policy in the SkateSafe® Handbook.

Space at Ontario Ice Skating Center is limited. Even though there are areas designated for costume changes, we recommend skaters plan to arrive with costumes on and hair & make up done.

U.S Figure Skating Travel Policy:

All travel must strictly adhere to Two-Deep Leadership requirements. An Adult Participant cannot transport a Minor Athlete one-on-one and Two-Deep Leadership requirements must be adhered to at all times during In-Program travel, by transporting at least two minors or a second Adult Participant. An Adult Participant cannot share a hotel room or other sleeping arrangement with a Minor Athlete(s). Full details of the SkateSafe® Travel Policy and any exceptions can be found starting on page 12 of the SkateSafe® Handbook.

SCHEDULE OF EVENTS:

The tentative competition schedule and groups will be posted on EntryEeze as soon as the information is available. Notification of the final schedule will be sent via EntryEeze and will be posted at the rink the morning of the competition.

PRACTICE ICE:

Depending on the number of competitors, if practice ice time and demand warrants, practice ice may be offered. If offered, final details for scheduling practice ice will be made available to competitors through Entryeeze. Music will not be played on Practice Ice. Practice Ice Fees are NON-REFUNDABLE AND NON-TRANSFERABLE.

PHOTOGRAPHY/VIDEOGRAPHY:

A professional photographer (Cynthia Slawter Photography) for award and action photographs will be at the rink.

Live and on-demand streaming, and sales and distribution of U.S. Figure Skating sanctioned and approved events, programs, and activities that include the playback of music is strictly prohibited. This prohibition does not apply to the distribution of footage that does not include music. Questions about this can be directed to music@usfigureskating.org

No photography or videotaping, except by the official photographer/videographer, without the express permission of the person being photographed or videotaped is allowed.

Parents, guardians, coaches, spectators and guests may record (both audio and/or visual) <u>only the skater</u> <u>which they have accompanied to the facility</u>. Recording any other person in the facility is strictly prohibited.

Solicitation by any photographer, or agent, of anyone to be the subject of still or video photography is not permitted. **NO FLASH PHOTOGRAPHY DURING THE EVENTS IS ALLOWED. This is for skater safety.**

SPECTATORS: No admission will be charged to the general public for the duration of the 59th Annual Arrowhead Open Championships.

ONSITE CHECK-IN:

Check-in will open on SUNDAY Oct 27, 2024 at Ontario Ice Skating Center. Check in Time will start At 7 AM at registration desk.

If you are participating in a role requiring compliance, please be sure to <u>download or print your</u> <u>compliance card</u> to verify your compliance status on-site, if requested. If you believe your compliance card does not accurately reflect your compliance status, please contact <u>skatesafe@usfigureskating.org</u> at least 2 business days prior to the competition for assistance.

AWARDS:

Medals for first, second, third and fourth place will be awarded for Showcase events. Trophies will be awarded to each skater placing first, second, third and fourth in Free Skating and also fifth and sixth place for Learn To Skate® USA events. When an event is subdivided into age groups, each division will have its own awards.

VOLUNTEER COMPLIANCE:

Reminder: Compliant positions at all U.S. Figure Skating events include LOC leadership, locker room monitors and <u>emergency</u> medical providers.

ACCOMMODATIONS: There is no official hotel, however there are several quality hotels/motels located near the Ontario International Airport, approximately four (4) miles east of the rink.
