We guarantee this puppy to the best of our knowledge, to be healthy and received its vaccines and de-worming through ____ weeks old. (Records included) The breeder is not responsible for the death or loss of this puppy once it leaves our premises. This includes but is not limited to sickness, accidents, personal injury, or theft. The breeder is not responsible for refunds due to human allergies, disabilities, illness, or other related situations. The breeder is not responsible for refunds due to color changes in coat and not bonding with the puppy because of temperament is not what you expected. As the breeder we try to the best of our ability to match each puppy to the likeness of the owner.

The owner assumes all financial responsibility for the puppy including but not limited to the vet expense, food, surgeries, boarding, grooming, etc.

The owner assumes responsibility to continue quality healthcare for the puppy. This puppy will require monthly worming (oral) and a series of vaccinations. You are highly encouraged to keep your puppy current with all necessary vet checks.

You have 10 business days to take the puppy to a licensed vet for a complete physical. Date _____ if for any reason the vet finds a defect in the puppy that will cause certain premature death the breeder agrees to refund the purchase price upon the return of the puppy to the breeder at the owner's expense. A refund will only be given upon a written report from the vet responsible for performing the exam. The vet will need to provide the breeder with all test results and diagnosis in WRITING. This refund will only be given provided that the breeder's vet of choice verifies the defect. Presence of parasites such as worms, giardia, or coccidian does not make the puppy defective. We attempt to send your puppy home parasite free. After the above date, the 5-day guarantee is not valid.

A 6-month guarantee against any genetic health problems such as eye or hip problems, this is from the date of birth and is only good for the original owners. If the puppy develops, any inheritable/genetic defect within 6 months from the date of birth buyers may return the puppy to the seller for a replacement puppy of equal value. Seller will provide replacement puppy when available from the next litter within the same price range. All shipping expenses to be paid by the buyer. Any diagnosis of hip dysplasia must be substantiated by the OFA. (Orthopedic Foundation for Animals) Buyer may elect to keep the puppy in which case, under no conditions and at no time during the life of the puppy will the seller pay or assist in paying veterinary expenses, including any such expense directly or indirectly related to any inheritable/genetic defects.

We can only offer our opinion at the time when the puppy is in our possession.

•At the time of sale, this dog/puppy is considered and being sold as pet quality. Scott and Kim Vandevender, breeder, offers no guarantee that disqualifying faults will not arise, at a later date, which would make this puppy unsuitable for the show ring or for breeding.

•10 day Vet Exam: (6-month replacement guarantee)

This puppy is guaranteed to be in good health at the time of delivery.

The buyer agrees to have the puppy inspected by a licensed veterinarian within 10 days of pickup (excluding Sundays and Holidays).

If the puppy is found to be in unacceptable health, a written statement from the veterinarian should be forwarded to the seller and the puppy should be returned within 5 days (at buyer's expense) for a replacement.

If the seller incurs any vet bills due to the condition the puppy is returned in, those will be deducted from the refund.

BUYER AGREES:

•Buyer understands puppy could live 10+ years and weigh 15+lbs at maturity.

•Puppy must be paid in full at the time of pick up.

•To have above puppy vet checked within 5 days of pickup •That all vet bills are the responsibility of the buyer.

•This dog is not to be used for breeding under any circumstances. Any breeding, even accidental, voids all guarantees.

•This contract applies to the original buyer only and is non-transferable to a second party.

•If the puppy should pass away for any reason in the first 6 months an autopsy MUST be performed at buyers' expense and results forwarded to breeder within 15 days.

TERMS OF REPLACEMENT:

If the above dog should develop a severe genetic disease before age of 6-months and can no longer function as a Pet/Companion Animal, the breeder will replace at no charge with a comparable puppy. The dog will be replaced either from the same litter or from a future litter. A proper letter from the vet stating the problem found and the vet's opinion on the viability of the animal must be sent to the seller within 15 days of diagnosis. The seller will have the final say on whether the original puppy must be returned or not. All the vet bills and returned shipping fees are the responsibility of the buyer and will not be accepted by the breeder. This guarantee does not include uneven bites, un-dropped testicles or umbilical hernia. Unless otherwise specified, all vet bills for corrective surgery, cosmetic surgery, shots and normal health care, euthanasia, spay/neuter and also shipping are the responsibility of the buyer.
