The breeder is not responsible for refunds due to color changes in coat and not bonding with the puppy because of temperament is not what you expected.** As the breeder we try to the best of our ability to match each puppy to the likeness of the owner. The owner assumes all financial responsibility for the puppy including but not limited to the vet expense, food, surgeries, boarding, grooming, etc.

**The owner assumes responsibility to continue quality healthcare for the puppy. This puppy will require worming (oral) and a series of vaccinations (often every 21 days up through 16 weeks of age). You are highly encouraged to keep your puppy current with all necessary vaccinations and vet checks. Owner must show proof of current vaccines (required by your state) and have maintained those vaccinations to retain the Health Guarantee in this contract.**

**You have up to \_\_\_\_\_ business days (date: \_\_\_\_\_) to take the puppy to a licensed vet for a complete physical.** If for any reason the vet finds a defect in the puppy that will cause certain premature death the breeder agrees to refund the purchase price upon the return of the puppy to the breeder at the owner's expense. A refund will only be given upon a written report from the vet responsible for performing the exam. The vet will need to provide the breeder with all test results and diagnosis in WRITING. This refund will only be given provided that the breeder's vet of choice verifies the defect. **The presence of parasites such as worms, giardia, or coccidian does not make the puppy defective. We attempt to send your puppy home parasites free, however, our region is prone to over 22 parasites due to our climate and lack of freezing weather.** If the presence of a parasite is found in fecal flotation test during the initial complete physical, we will reimburse for Medication and Treatment, up to 150.00 maximum.

**One Year guarantee against any genetic health problems from the date of birth and is only good for the original owners.** If your dog is found and certified to have a congenital or hereditary condition which adversely affects the health of the dog by licensed veterinarian or major insurance provider, Alli & Gator Puppy Enterprise LLC will provide reimbursement of reasonable, documented, insurance deductible and copay, up to the purchase price of the puppy, or replace with another puppy, or issue a refund.
