Stalling and Camping Reservations

Stall Information:

- All horses staying overnight at 7 Downs must be stalled – No Tie Outs or Portable Fences Allowed.
- Stall and RV reservations will not be accepted without payment.
- Stalls, pens and RV's will be reserved for Dash and Dance Contestants (and/or horse owners) only.
- Stallion Stalls are located in the same barns as other covered stalls and will be located on end of each barn and are lined with plyboard to prevent interaction with neighboring horses.
- Pens vary in size and are located by the RV hookups/Outdoor arena and near the indoor arena.
- Covered Barn priority will be given to those who are arriving Sun – Wed and have stalled in the same location year after year. Stalling preference cannot be guaranteed.
- There is a limited number of RV hookups – preference will be given to those arriving earlier in the week.
- Camping Hookups are on the West end of property near the outdoor arena.
- Generators are allowed near stalls or in parking lot at no charge.
- Move In – all stalls will be assigned and labeled. Stalls will be unlocked the morning of purchasers arrival date.
- Due to another large equine event in the area, the front gate to the property may be locked from Sunday through Thursday morning. Arrangements will need to be made ahead of time if stalling during these days.
- Shavings will be available on a limited basis at \$12 per bag.
- **A stall map will be posted and stalls unlocked the morning of your arrival. Text or Call Amy at 605.641.3518 to make arrangements if your arrival date changes**
- Please be patient – our stall crew is also our barrel production crew.
