

UX Goodbye Lil Joe

Stallion Service Contract

Stallion manager and mare owner agree to breed _____ REG

_____ to the stallion **UX Goodbye Lil Joe** for the _____ (year) season for \$1500.00.

The contract will be based upon the following terms and conditions.

1. The non-refundable booking fee of \$500.00 is payable at the time this contract is signed. The stallion fee and the balance of all other associated fees will be paid prior to the mare's departure from the breeding farm or prior to shipment of semen. The balance of any other fees or expenses will be paid in accordance with terms of this signed agreement.
2. Sitnal Livestock, LLC, agrees to provide suitable facilities for the care and feeding of the mare with or without foal. Mare owner agrees to pay for care and feed at the rate of \$25.00 per day for dry mare, \$30.00 per day for wet mare. Should the mare owner want his/her mare to have more or different feed or stalls than what the breeder's facilities normally supplies, it will be up to the mare owner to arrange this with the breeder's facility. The price will be adjusted accordingly.
3. The mare should be healthy and in sound breeding condition. Free from infectious, contagious, or transmittable diseases. A current negative coggins test and a photocopy of registration papers, on both sides, will be required when mare is delivered. Mares that are not halter broken will not be accepted. Breeder and/or Veterinarian reserves the right to refuse any mare. If the mare is refused, the booking fee shall constitute liquidated damages.
4. The contract contains a "live foal guarantee." A live foal is described as a newborn foal, which stands and nurses without assistance. If the foal is born dead, there are return privileges for the following year. Sitnal Livestock, LLC, needs to be notified within a 24-hour period following the birth and death of the foal, and needs to receive a veterinarian's certificate confirming an acceptable cause of death, at the sole discretion of Sitnal Livestock, LLC. Should a rebreed be approved by Sitnal Livestock an updated rebreeding contract will be necessary to be agreed to and signed, which includes the additional fees and expenses involved, such as a chute fee of \$400.00 along with the standard breeding, shipping, mare care, or other expenses.
5. A "Breeder's Certificate" will be issued for the foal, conceived by this mating under these conditions: 1) The stallion fee and all other expenses are paid in full; 2) Mare has produced a live foal by this mating.
6. In the event that the stallion should die or become unfit for breeding purposes, or if the mare should die or become unfit to breed, this contract shall terminate and any money paid on the stallion fee, excluding the booking fee, shall be refunded to the mare owner.
7. Shipped semen: Prior to shipment the mare owner must pay the following: 1) The stud fee of \$1,500.00; 2) Equitainer deposit of \$150.00; 3) \$350.00 for the collection and shipment of the semen. Sitnal Livestock, LLC takes no liability or responsibility for any semen shipments lost, delayed, or damaged during transport.
8. The equitainer should be returned to the veterinarian/breeder by the fifth day in good repair. The deposit will be returned, or check will be voided and destroyed once Sitnal Livestock, LLC, or the Breeder or Breeders Veterinarian receives the equitainer, and no future shipments are expected.

9. All mares breeding at the farm will be artificially inseminated. The expenses associated with this will be charged to the mare owner. The Breeder is not a Veterinarian and it is the mare owner's sole responsibility to have their own veterinarian confirm the health and existence of the pregnancy within 20 days of pickup.

10. Sitnal Livestock, LLC will try to settle the mare between March 1st, through July 15th. The Mare owner agrees to allow Sitnal Livestock, LLC ample opportunity to settle the mare, including specifically breeding the mare through at least three (3) heat periods. If for any reason the mare does not settle, the Mare Owner will hold Sitnal Livestock, LLC, and all related people, and entities harmless.

11. This contract is entered into in the state of South Dakota and will be interpreted and enforced by the laws of and in Lawrence Co, South Dakota.

12. When signed by both parties, this document will become a legally enforceable contract binding both parties.

13. This contract is neither transferable nor assignable. In the event the mare is disposed of prior to the birth of the foal, the "Live Foal Guarantee" will be void, unless an amended individual agreement has been made with Sitnal Livestock, LLC.
