

General Indemnity:

- 1.All persons, enter the premises, enter at their own risk and he/she shall have no claim against the Company or its employees or its agent in the event of any accident or loss involving a person(s) whilst on the premises of the Company or while taking part in an event(s) (paintball/abseiling/river rafting) or whilst being transported to a destination, as requested by a person(s) or from any cause whatsoever, including but not limited to any negligence or defect by the Company or any of its employees, or its agent or any other person on the premises. All persons entering the premises waive their rights to institute a claim against the Company or its employees, or its agent arising out of personal injury to him/her. Such waiver is also given in their capacity as guardians of his/her dependents (should this be applicable).
- 2. All persons, bags, parcels, and other items may be subject to security checks at the point of admission to the premises and at such other locations inside the premises as the management of the company consider appropriate
- 3. No Firearms are allowed on the premises
- 4. No Dangerous or hazardous materials will be allowed on the premises
- 5. No Strippers are allowed on the premises
- 6. No vandalism shall be tolerated
- 7. Music will only be allowed until 00h00, unless cleared with the person in charge at the venue
- 8. For your safety and to avoid injury, all persons must comply with all notices, and all directions and requests of the management and/or any employee, posted, given or made
- 9. The management and/or employee of the company may photograph, film, videotape, record or otherwise reproduce the image and/or voice of any person who enters the premises and use the same for any purpose without payment to any person
- 10. Defacing of rocks or trees is forbidden
- 11. PLEASE, leave no trash of any kind, including cigarette butts, wrappers, glass etc
- 12. No fires are allowed except at demarcated braai areas 13. Be careful when smoking as a person will be responsible, in terms of the Fire Prevention Act, for all fire damage caused by that person
- 14. Should any of the aforementioned rules not be adhered to the management of the company reserve the right to not refund the holding/breakage deposit
- 15. Should any loss occur the management reserves the right to deduct the reasonable value of the loss from the holding/breakage deposit
- 16. Right of admission is reserved
- 17. Any misconduct will not be tolerated and the management reserve the right to not refund the holding/breakage deposit or ask you to leave the venue immediate



- 18. Any damage cause to the venue will be for the account of the client arranging the function and the person that caused the damaged
- 19. Check in times: from 14:00 to 18h00, check out: 10:00. Early check in or late check out can be arranged R300 fee.
- 20. All Units are self-catering, except for groups who pre-booked meals. Towels are not provided, but bedding is.
- 21. There is no need to check-in; guests can proceed straight to booked facility/venue.
