CUSTOMER RESPONSIBILITIES

Customer agrees to:

1. Provide clear access for delivery/setup.
2. Ensure setup area is free of rocks, debris, pet waste, sprinklers, and hazards.
3. Provide working electrical outlet within 75 feet unless generator rented.
4. Have an adult (18+) supervise inflatable at all times.
5. Follow all posted and listed safety rules.
6. Keep children separated by age/size.
7. Stop use immediately during rain, lightning, or strong winds.
8. Keep blower running at all times while in use.
9. Prevent shoes, food, drinks, gum, face paint, silly string, sharp objects, pets, or smoking near equipment.
10. Notify company immediately of damage or deflation.

SAFETY RULES

- No flips, wrestling, roughhousing, climbing walls, or hanging from netting.
- No adults unless specifically approved for unit.
- Maximum riders at one time must be followed.
- One rider at a time on slides unless designed otherwise.
- Exit immediately if unit begins losing air.
- Keep entrance clear at all times.

WEATHER POLICY

For safety, NXT LVL VIBES EVENTS & ENTERTAINMENT may cancel or suspend rentals due to unsafe weather. If the weather prevents rentals being used, a full refund or a partial refund depending on the situation will be issued.

Customer agrees to stop use immediately if any of the following occur:

- Rain
- Lightning
- Winds become unsafe
- Dust storm conditions

No one may use inflatable during unsafe weather.

DAMAGE / CLEANING / LOSS

Customer is responsible for damage beyond normal wear including:

- Tears or punctures
- Burn marks
- Water damage to dry units
- Silly string damage
- Pet damage
- Theft or missing items
- Excessive dirt / mud / food mess

Repair, cleaning, or replacement charges may apply.

CANCELLATION POLICY

Deposits are non-refundable unless company cancels due to unsafe weather or availability issues. Reschedules may be offered at company discretion.

RELEASE OF LIABILITY / ASSUMPTION OF RISK

1. Customer understands inflatable amusement equipment involves inherent risks including falls, collisions, rough play injuries, weather-related hazards, and misuse injuries.
2. Customer voluntarily assumes all risks associated with use of rented equipment and agrees to release, waive, and hold harmless NXT LVL VIBES EVENTS & ENTERTAINMENT, its owners, employees, contractors, and affiliates from claims for injury, death, loss, or damage arising from use of rented equipment, except where prohibited by law.
3. Customer accepts full responsibility for guests, children, and attendees using equipment during rental period.

INDEMNIFICATION

Customer agrees to defend, indemnify, and hold harmless NXT LVL VIBES EVENTS & ENTERTAINMENT from claims, damages, attorney fees, or liabilities caused by customer, guests, misuse, negligence, or violation of safety rules.

PHOTO RELEASE (OPTIONAL)

- Customer grants permission for photos/videos of setup/event (without personal identification) to be used for promotional purposes.
- Declines photo use.
