NEW BUSINESS

1. Tournament entry fee for 2024 will now be \$75.00.

2. The One Day Championship is going forward with the committee working on criteria and the playoff format.
3. The Rules Committee for 2024 is on the website.
4. The 2025 schedule will most likely have changes due to issues at some clubs, specifically, Greenville, Holly Tree, and Cliffs Valley, however, the tentative is as follows: April- Holly Tree, May-Catawba, June- Champion Hills, July- Cliffs Valley, August- Cleveland, September- Greenville, and October- Spartanburg (Championship).
5. Roster and Dues (\$30/person) are due no later than March 31. Make sure to check the handicap index for each play as there is a maximum of 33.0 to be qualified to play and, make sure that each player's information is correct. Send one check from the club along with the roster to **WCWGA, c/o Barbara Anderson, 209 McDaniel Greene, Greenville, SC 29601** no later than March 31, 2024. 6. Club data needs to be updated and returned to Kathy Morgan and Andrea D'Avignon. Updates that are needed are names of the club pros, club information, etc.
7. President Morgan reported that the 2024 season will be the 70th Anniversary of the WCWGA and recognized the 3 charter member clubs, Asheville, Greenville, and Spartanburg. Catawba was a charter member but, left in 1990 and rejoined in 2007. Hendersonville joined 2 years later in 1956. The officers would like to have a big celebration for the 75th anniversary in 2029.
8. President Morgan reported on the Officers Projects which are the By Law changes that will be voted on at the Spring Meeting, the One Day Championship, the Cliffs Mountain Park membership, the Nominating Committee finding a 2nd VP for 2025 and the New Club Committee.

The Spring Board of Directors meeting will be April 24, 2024 at 8:00 am at Thornblade followed by the Spring General Membership meeting after tournament play.
