Application Deadline

December 30, 2025

Eligibility Criteria

Applicants must fulfill one of the following primary qualifications:

- Be a licensed pharmacist with a minimum of 10 years of experience in a specialized field of pharmacy, OR
- Be a licensed pharmacist who has completed residency training in a specific field from a recognized institution in the United States or the United Kingdom **or other countries recognized by IAI**

Additional requirements include:

- Completion of the online module **“Introduction to Digital Health”** (Coursera).
- Documented **Professional Contribution**, such as:
 - Peer-reviewed publication
 - Widely disseminated work
 - Recognized innovation
 - Development of national or institutional guidelines that are widely adopted
- Member of The Indonesian Pharmacists Association (IAI)
- No history of involvement in illegal or unethical practices

Required Documents (PDF format)

Applicants must complete the **FAPA CP Fellowship Online Form** and submit the following documents:

- Fellowship Application Form (link: <https://bit.ly/fapacp-batch2-2026>)
- Executive Summary of **Professional Contribution** (see guidelines below)
- Comprehensive **Curriculum Vitae (CV)** in English with emphasis on professional experience and contributions
- Certificate of completion of the **Introduction to Digital Health** module (collected later)
- Certificate of residency training (if applicable)



Guidelines for Executive Summary of Professional Contribution

Applicants must prepare and submit an **executive summary of their professional contribution** (no page limit). The content should clearly reflect the candidate's expertise.

The summary may include (but is not limited to):

- Title
- Area of specialization
- Introduction / background
- Description of the work and candidate's role
- Outcomes and impact
- Benefits and potential for scale-up
- Supporting documentation or data
- Candidate's contribution to the work (if team-based, specify the candidate's role and leadership)

Note: The above list is illustrative. Candidates may include additional elements that best demonstrate their professional contribution.

Evaluation Process

Shortlisted candidates will undergo a **two-stage evaluation**:

1. **Closed-book written examination** (Bahasa Indonesia or English)
 - Candidates will respond to questions regarding challenges in their practice area and propose ideas for improvement.
2. **Zoom presentation and interview**
 - **10 minutes presentation (in English):** Candidates will present their **Professional Contribution** as outlined in the executive summary.
 - **20 minutes interview:** The evaluation committee will further explore the candidate's professional contributions, motivation, vision for advanced training, and commitment to supporting FAPA CP Indonesia.

Expectations of Fellowship Recipients

- Recognition as a **Fellow of the FAPA CP Indonesia Chapter (FACP)**
- Attendance at the **FAPA CP Session during the FAPA Congress 2026 in Thailand**
- Ongoing responsibilities:
 - Provide **strategic leadership** for FAPA CP Indonesia
 - Develop and implement **training curricula** to strengthen professional competencies
 - Represent FAPA CP Indonesia in **national and international forums**
 - Mentor and guide future leaders in pharmacy practice and education
