

## FOUR SEASONS RACQUET CLUB LLC ASSUMPTION OF RISK, WAIVER OF LIABILITY AND PARENT/GUARDIAN PERMISSION FORM

In order to participate in Four Seasons Racquet Club LLC activity, each participant must submit a signed version of Assumption of Risk, Waiver of Liability and Parental Permission Form. This agreement is for the individual and all the family members.

## PLAYER AGREEMENT

I affirm that my participation at Four Seasons Racquet Club is entirely voluntary, and I understand that participation at Four Seasons Racquet Club involves a risk of injury or illness due to certain inherent risks that cannot be eliminated regardless of the care taken to avoid such illness or injuries.

I understand that the best way to make sure that I remain safe and avoid injury is to follow the rules, regulations and instructions of staff of Four Seasons Racquet Club. I agree that I will learn and obey all the rules and regulations and will follow all instructions of the staff at Four Seasons Racquet Club.

<u>PARENT/GUARADIAN AGREEMENT</u>: I agree to allow my child/ward to participate at Four Seasons Racquet Club and affirm that my child's/ward participation is completely voluntary. I understand that there are risks inherent in the activities my child will engage in at Four Seasons Racquet Club which may cause serious illness or injury. I also understand that, despite safety precautions, Four Seasons Racquet Club cannot guarantee that my child/ward will not be injured. My child/ward and I are willing assume these risks. To minimize risk, I have instructed my child/ward to obey all the rules, regulations and instructions at Four Seasons Racquet Club.

## ASSUMPTION OF RISK, WAIVER OF LIABILITY, RELEASE & AGREEMENT NOT TO SUE:
